Garver and Terri D. Garver**, a married couple (herein referred to as grantor), does grant, bargain, sell and convey unto **Charlie H. Richardson and Kathryn H. Richardson**, (herein referred to as grantees), for and during their joint lives, and upon death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

Lot 313, according to the Survey of Brook Highland, Seventh Sector, as recorded in Map Book 13, Page 99, in the Office of the Judge of Probate of Shelby County, Alabama.

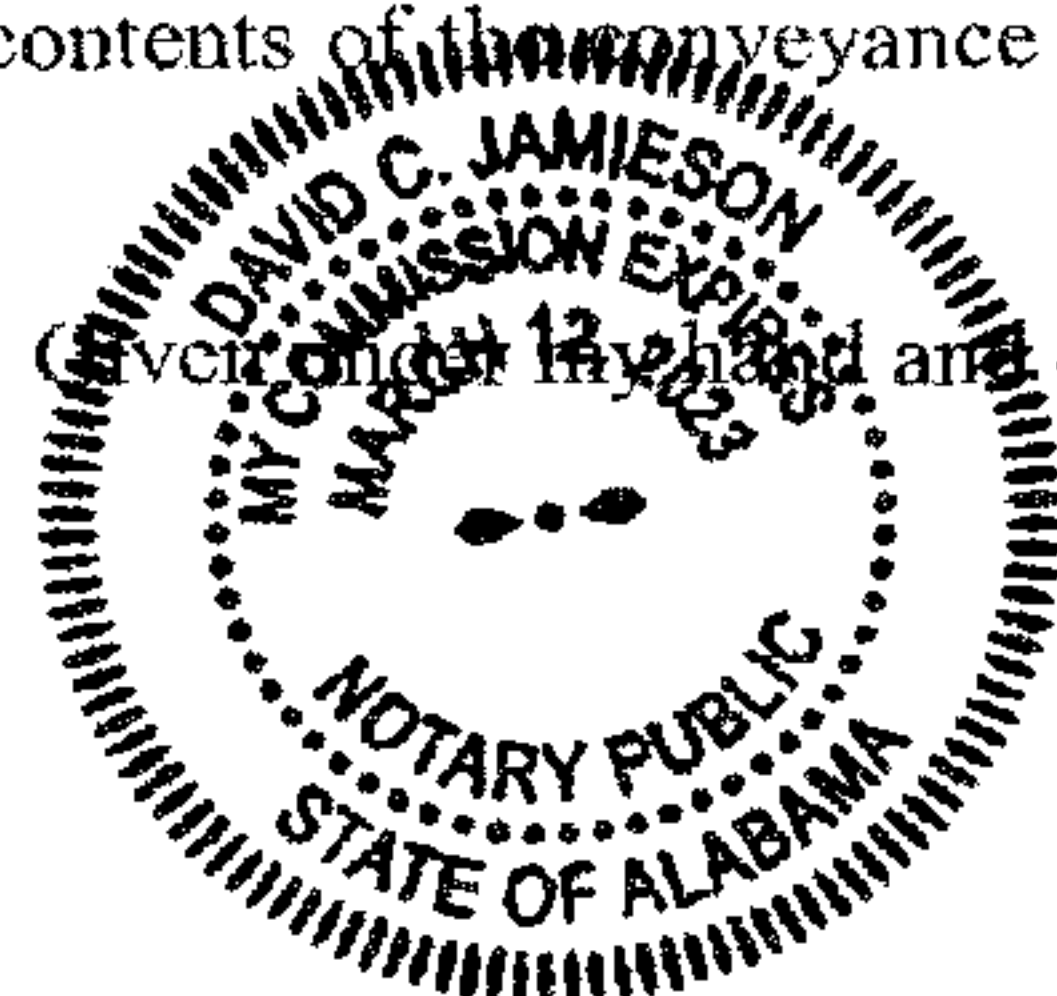


