WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA

KNOW ALL MEN BY THESE PRESENTS,

That for and in consideration of **TWO HUNDRED FORTY THOUSAND AND NO/100 (\$240,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **JAMES WALKER, JR. and HOLLY WALKER**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **THOMAS D. OCHSENFELD and STEPHANIE S. OCHSENFELD**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 28A, according to the Amended Hillsboro Subdivision Phase I, as recorded in Map Book 39, Pages 140 A, B, and C, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2019 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

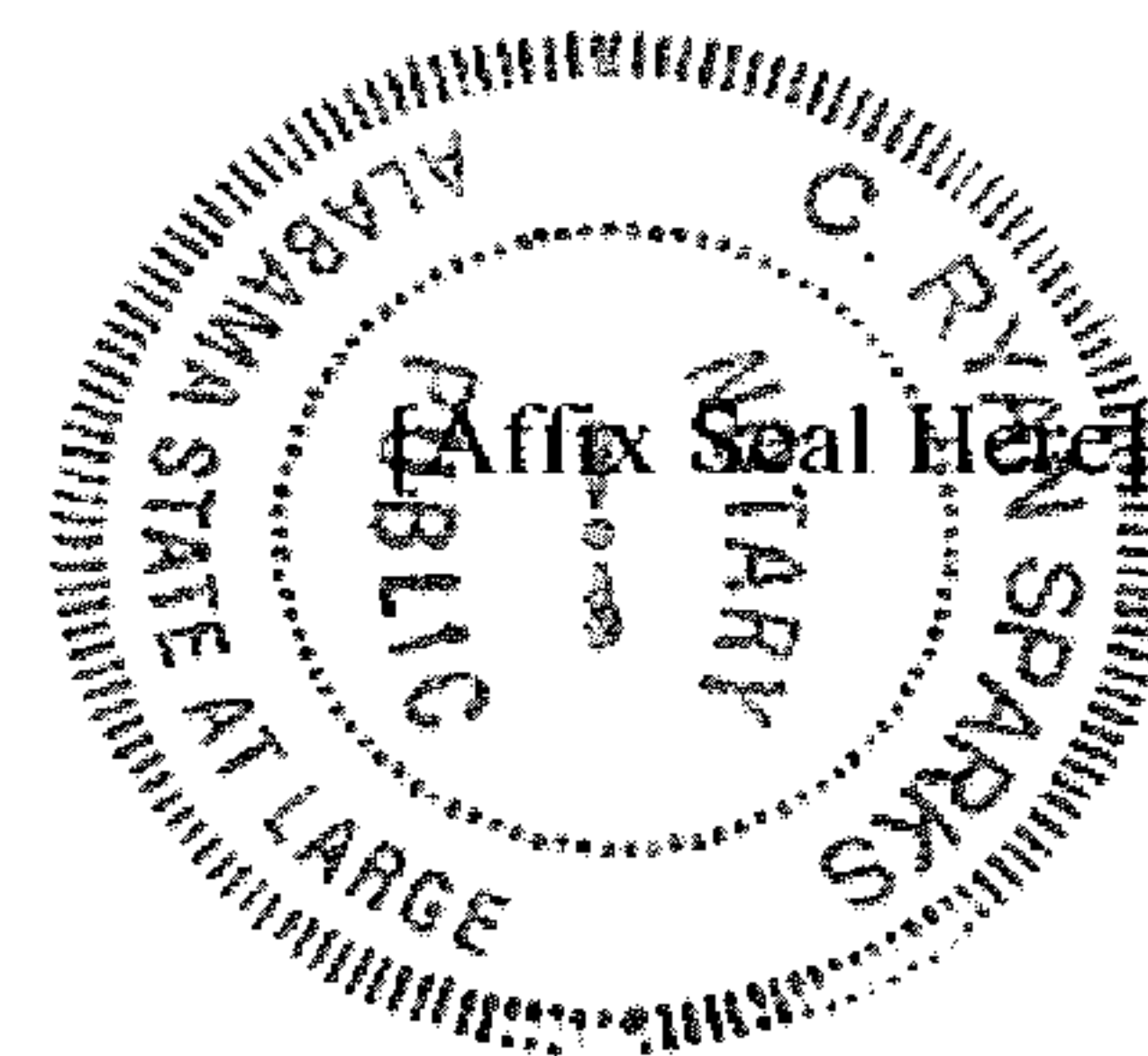
