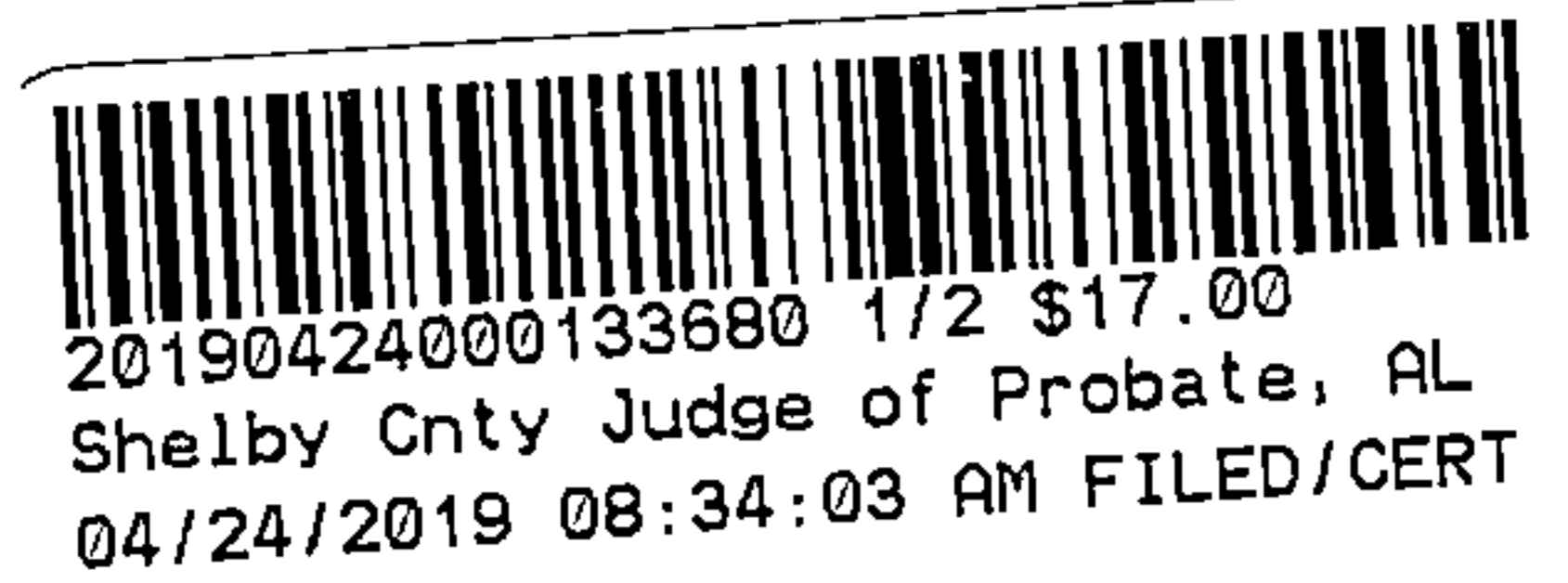

**CERTIFICATION OF TRUST
FOR SYDNEY S. ALLEN TESTAMENTARY TRUST**

The undersigned, Thomas Durrett Allen, Jr. a/k/a Thomas D. Allen, Jr., being first duly sworn, deposes and says he is at least 19 years of age and is a currently acting trustee of the Sydney S. Allen Testamentary Trust, and further states as follows:

1. The Sydney S. Allen Testamentary Trust is a valid, existing trust, having been created by the Last Will & Testament of Sydney S. Allen, Deceased, and Codicil thereto, on April 9, 2018.
2.
 - A. The original settlor of the trust is Sydney S. Allen.
 - B. The following person(s) contributed money, funds, real property, or personal property to the trust: Sydney S. Allen.
[This does not include investment income such as rental payments.]
 - C. The settlor died on November 9, 2017, and her estate is currently pending in the Probate Court of Shelby County, Alabama, Case Number PR-2018-000071.
 - D. The name and address of the currently acting trustee is Thomas Durrett Allen, Jr., a/k/a Thomas D. Allen, Jr.
 - E. The named successor trustee is Lynn A. Ortis.
3. The Sydney S. Allen Testamentary Trust has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.
4. The administrative and/or managerial powers of the trustee are unlimited and unrestricted but as more specifically described in Item VI of the Last Will & Testament of Sydney S. Allen, Deceased.
5.
 - A. The trust is revocable.
 - B. The person(s) holding the power to revoke the trust is Thomas Durrett Allen, Sr., Thomas Durrett Allen, Jr., and Lynn A. Ortis.
6. There are not multiple trustees.
7. The conditions for the succession of the successor trustee is renunciation and/or death of the primary trustee.

8. The social security number is redacted but available by contacting the Trustee.
9. Trust Property should be titled as follows:
"Sydney S. Allen Testamentary Trust as created by the Last Will & Testament of Sydney S. Allen, Deceased, and Codicil, as recorded in the Probate Court of Shelby County, Alabama on April 9, 2019."
10. To the best of the undersigned's knowledge, the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.

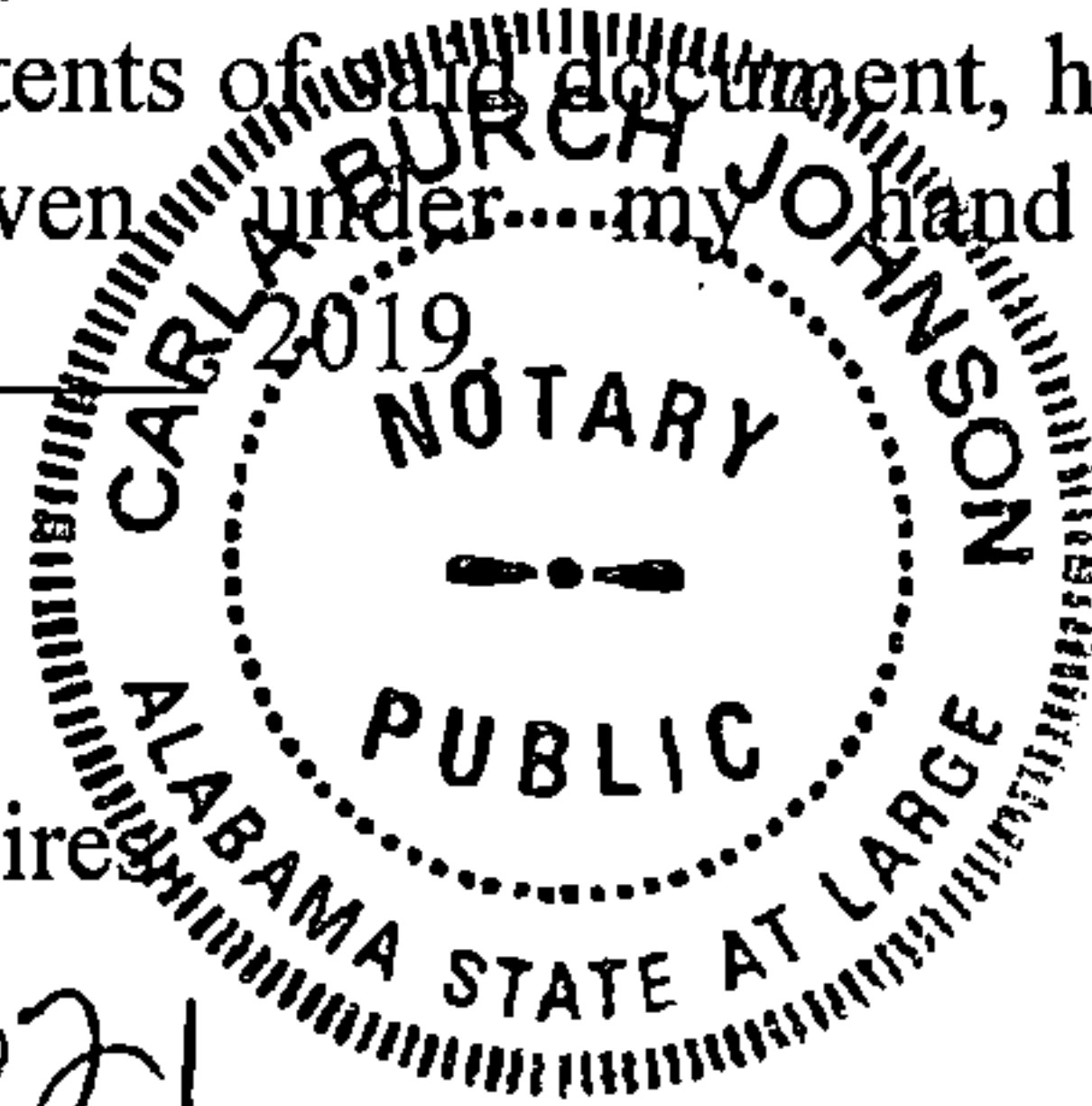
