County of Shelby

That in consideration of the sum of **One Hundred Thousand Dollars and No Cents (\$100,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Jeffrey Brett Arnold, a married man and Kecia Arnold Braswell, a married woman**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Gary Dean Bolton and Pamela K. Bolton**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot No. 33 in Allendale Subdivision, according to map of said Subdivision, which is recorded in the Probate Office of Shelby County, Alabama in Map Book 4, Page 78. Situated in Shelby County, Alabama.

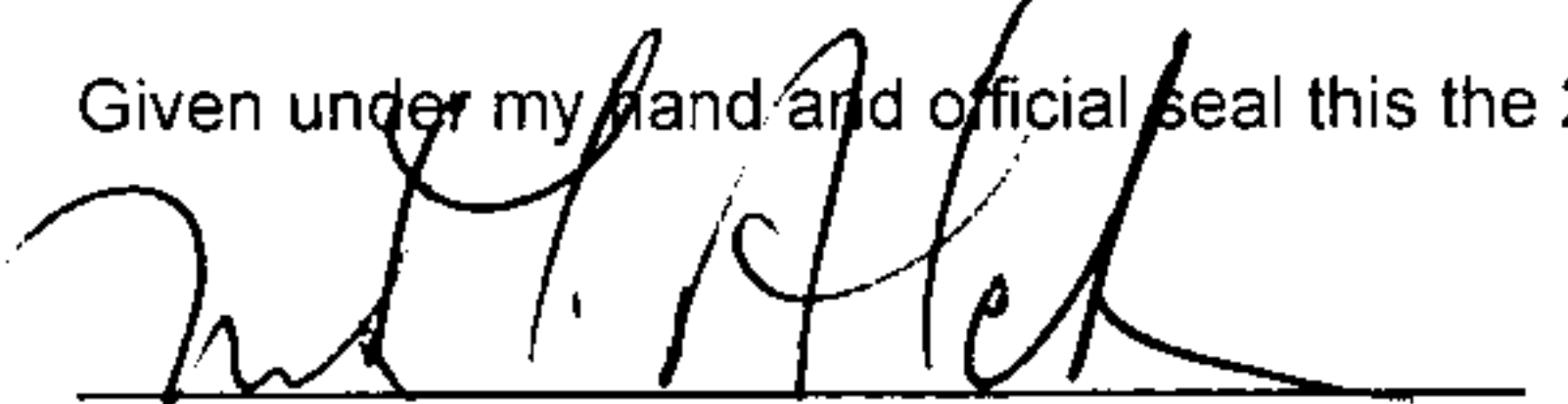

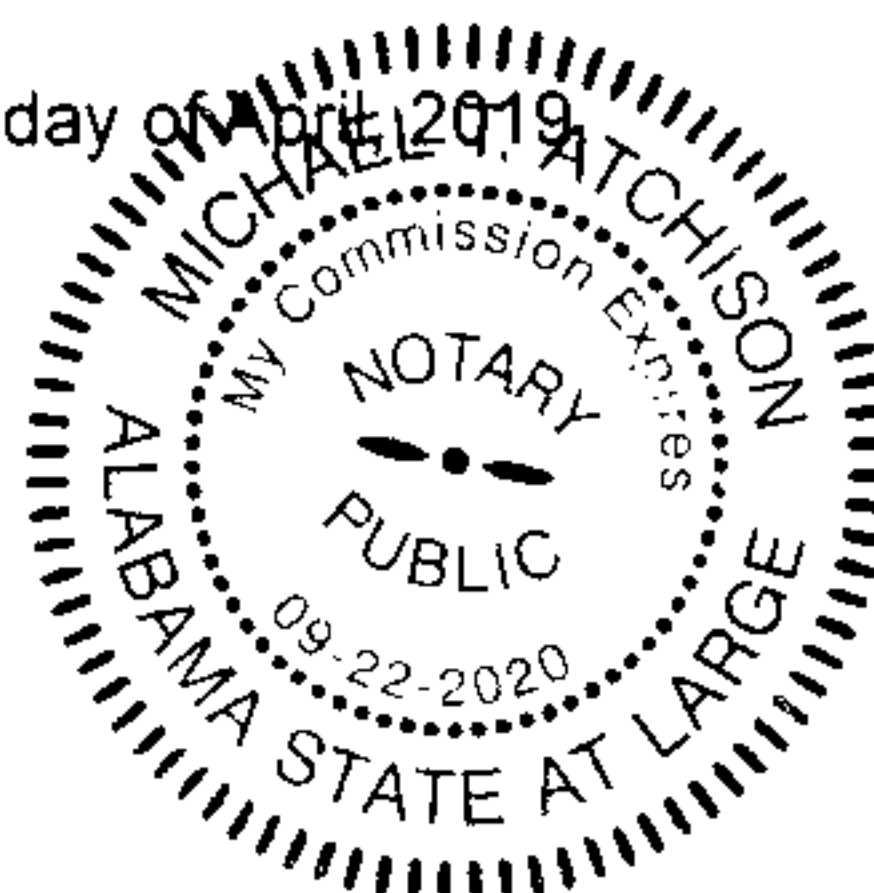
