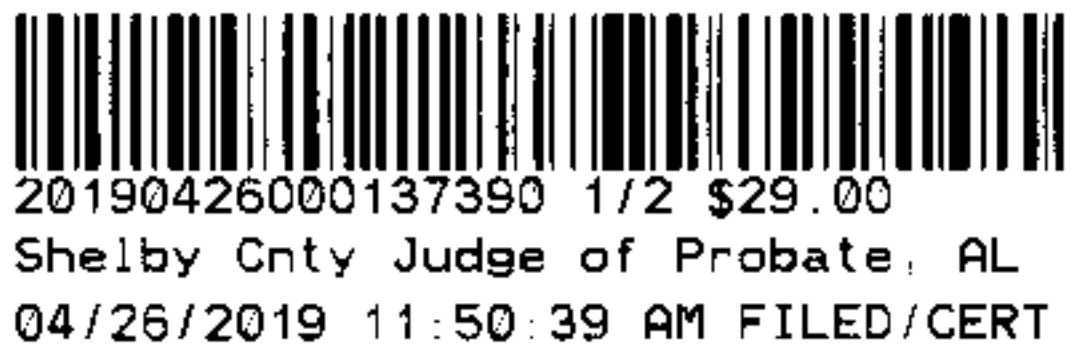

WARRANTY DEED

SHELBY COUNTY ) **KNOW ALL MEN BY THESE PRESENTS:**

That in consideration of TEN THOUSAND DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

**TED DIAL AND WIFE, DEBORAH DIAL**

(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

**TED C. DIAL, SR., AND DEBORAH R. DIAL, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE DIAL LIVING TRUST, DATED APRIL 18, 2019 AND ANY AMENDMENTS THERETO.**

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 25, Block 1, according to the Amended Map of Southlake Crest, 2nd Sector, as recorded in Map Book 19 page 14 in the Probate Office of Shelby County, Alabama.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said **GRANTEE**, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said **GRANTEE**, his, her or their successors and assigns forever, against the lawful claims of all persons.

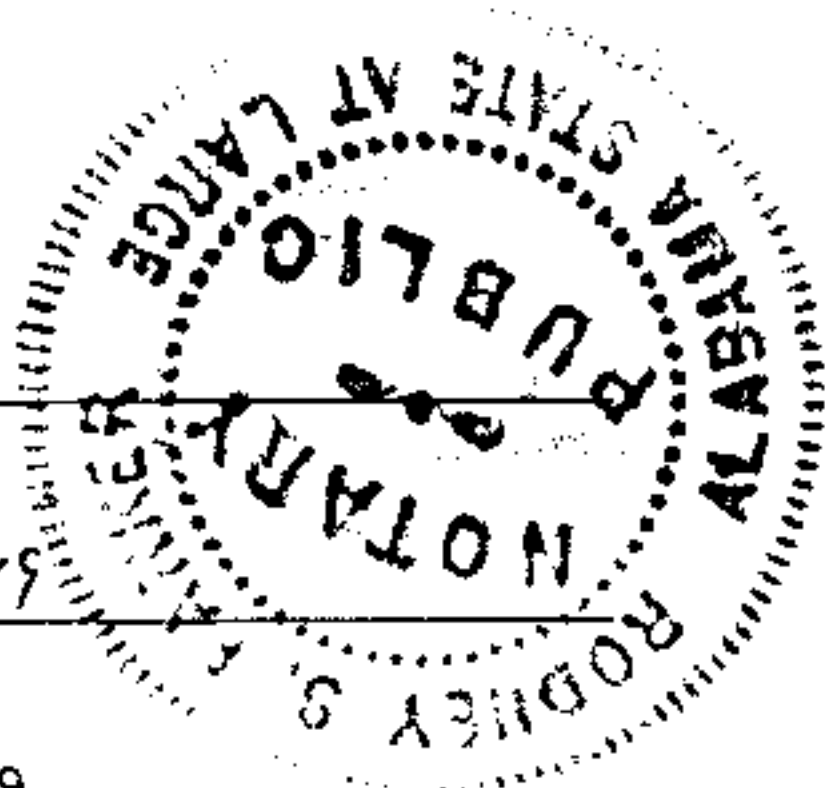
