WARRANTY DEED

} Know All Men by These Presents,

Shelby County

That in consideration of the sum of **One Hundred Forty Seven Thousand Five Hundred Dollars and No Cents (\$147,500.00)** to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, I, **Meredith S. Stovall, a single woman** (herein referred to as grantor), does grant, bargain, sell and convey unto **Gerald P. Nichols and Keri M. Higginbotham** (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

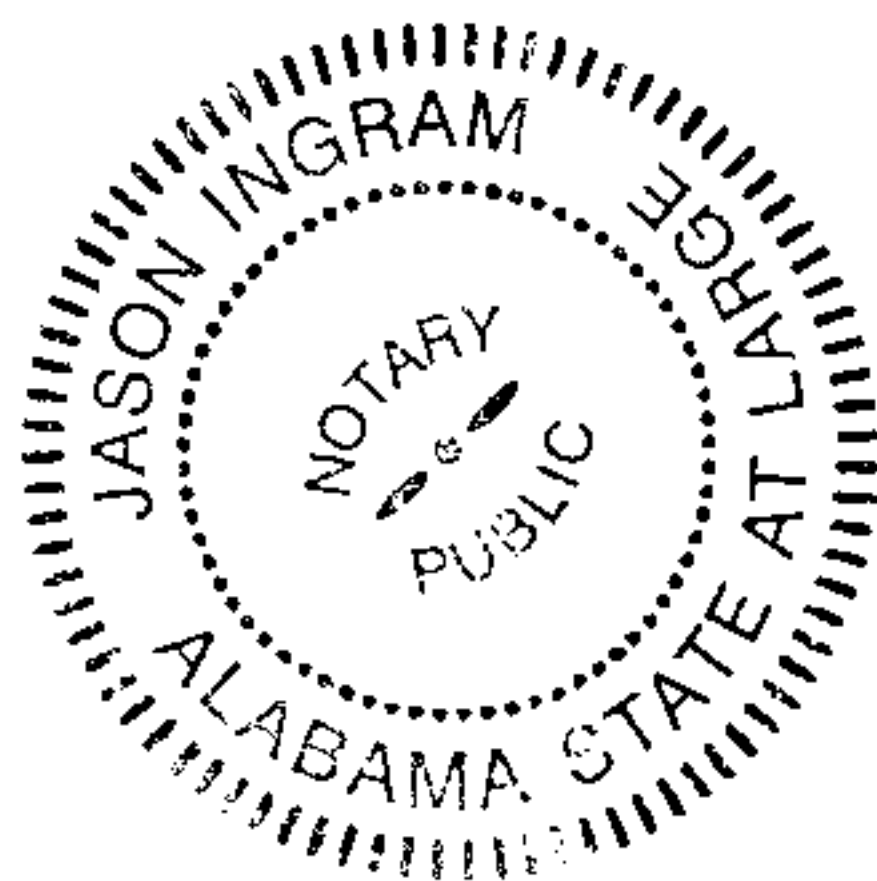
