Lot 43A, Brook Forest Addition to Wyndham, as recorded in Map Book 27, Page 25, in the Probate Office of Shelby County, Alabama.


Subject to: All easements, restrictions and rights of way of record.



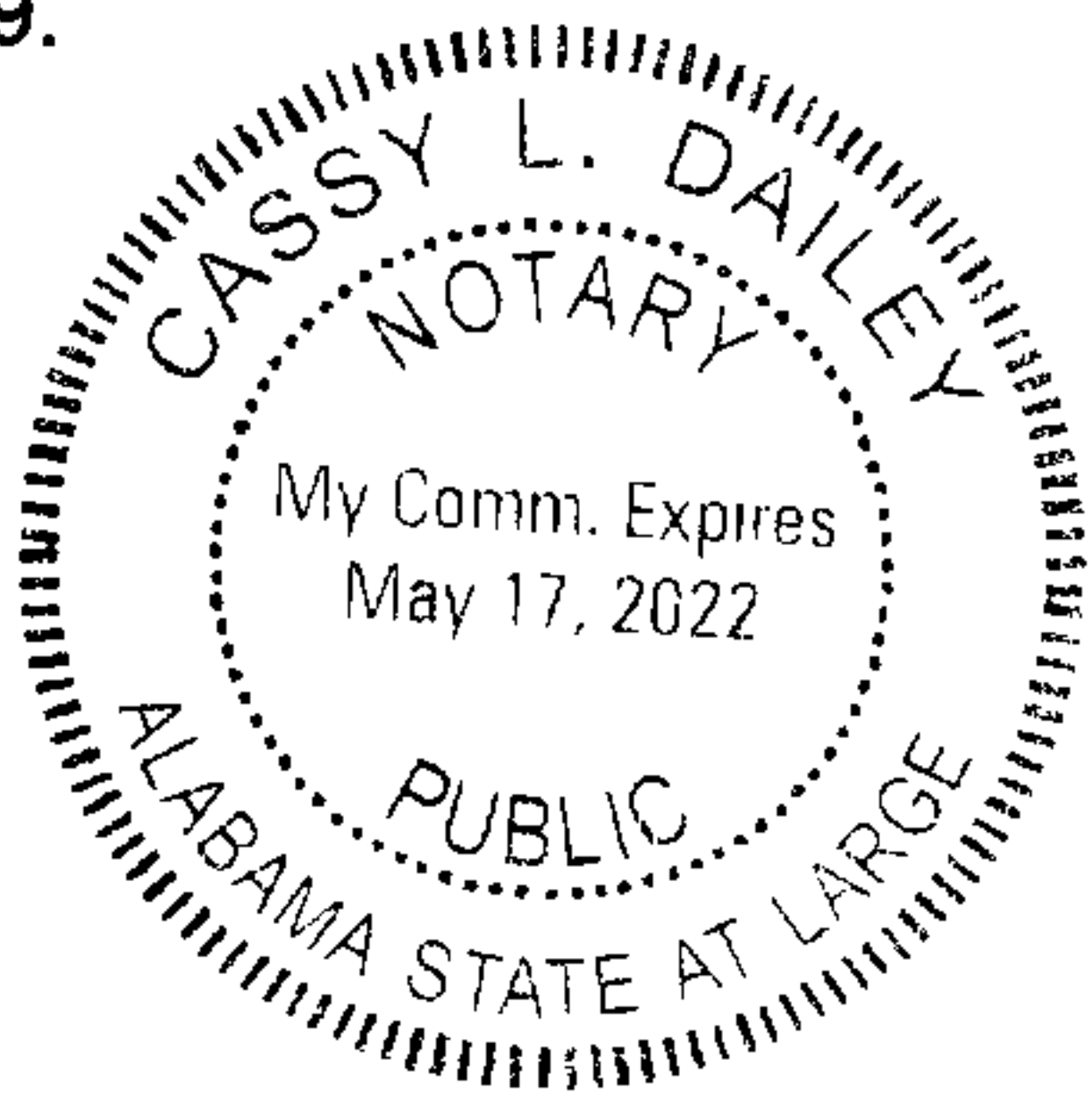
