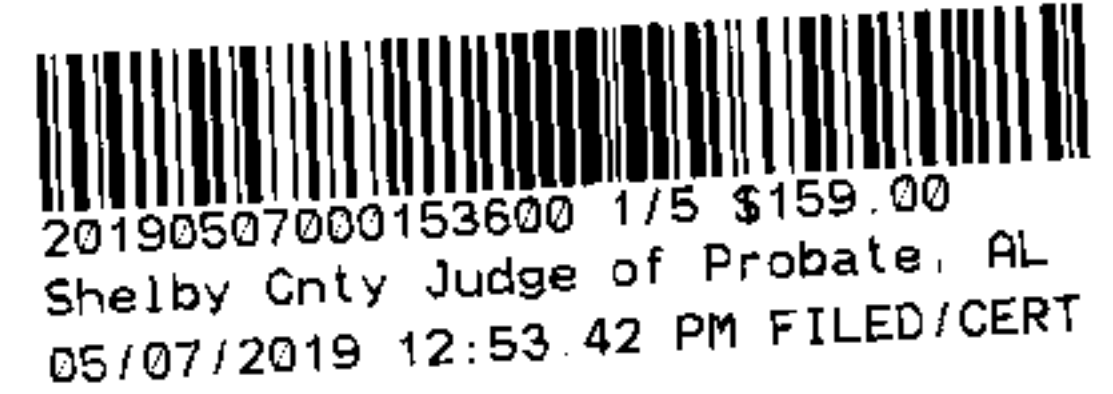

DOMESTIC LIMITED PARTNERSHIP (LP)
STATEMENT OF DISSOLUTION

PURPOSE: In accordance with Section 10A-9A-8.02 of the Code of Alabama 1975 a dissolved Limited Partnership that has completed winding up may deliver for filing in accordance with Section 10A-9A-8.02(b)(1) a Statement of Dissolution.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed Dissolution along with the appropriate filing fees to the Office of the Judge of Probate in the county where the Partnership's original Certificate of Formation was filed. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money order payable to the Secretary of State for the state filing fee of \$100.00 and the Judge of Probate's Office will transmit the fees along with a certified copy of the Dissolution to the Office of the Secretary of State within 10 days after the Dissolution is recorded. You may pay the Secretary of State fee by credit card if the county you are filing in will accept that method of payment (see attached). Your filing will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored (\$30.00 fee).

A Statement of Dissolution must be signed by all general partners or by the person appointed pursuant to Section 10A-9A-8.03(b) or (c) to wind up the dissolved Limited Partnership's activities and affairs. 

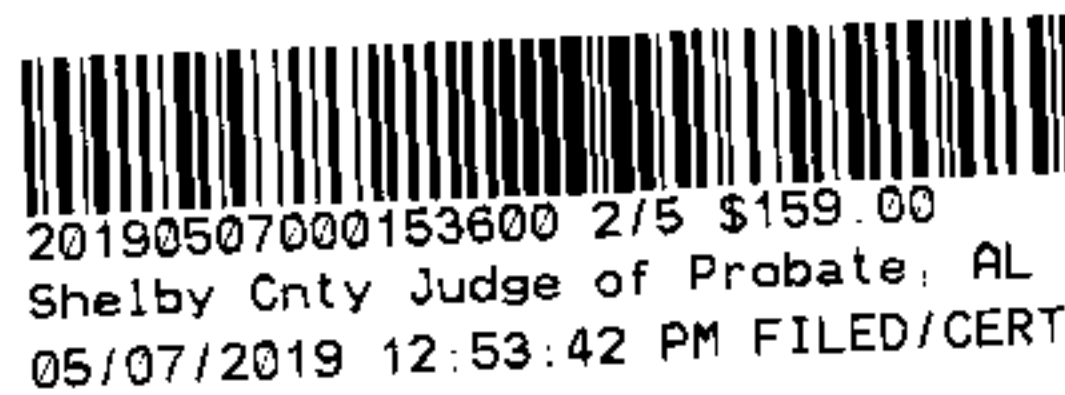

ASSIGNMENT OF INTERESTS IN CHELSEA FARM PARTNERSHIP, LTD.

Whereas, Stacy W. Barnett ("Stacy") and her brother, Scott L. Weygand ("Scott") each own a 1/400th (.25%) interest in Chelsea Farm Partnership (the "Partnership") along with their father, Laurence D. Weygand ("Larry"), who owns the remaining 398/400 (99.5%) interest of the Partnership,

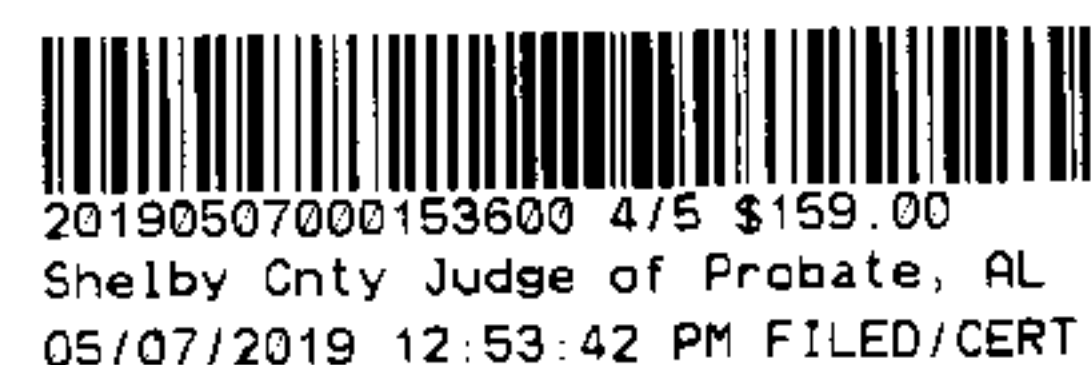
Whereas, Stacy and Scott each desire to conclude their involvement in the Partnership and sell their respective 1/400 interest therein to Larry for \$6,250.00 (for each 1/400 interest) so that Larry will then own 100% of the Partnership and may terminate the Partnership and transfer all assets owned by the Partnership to himself;

Whereas, Stacy and Scott each acknowledge that the sales price of \$6,250.00 for their respective 1/400 interest in the Partnership is a fair price for each of them to completely and fully convey all of their interest in the Partnership to Larry;

Whereas, Stacy and Scott each acknowledge that they have received the aforesaid \$6,250.00 and that such payment is good and sufficient consideration for them to sign this assignment; and

Whereas, Stacy and Scott each desire for their father to own all of the assets of the Partnership and to assume all liabilities associated therewith,

BE IT RESOLVED THAT: In consideration of the collective payment of \$12,500.00 to Stacy and Scott by Larry (that is, \$6,250.00 to both Stacy and Scott) Stacy and Scott do hereby assign, grant, bargain, sell and convey their respective 1/400 interest in the Partnership to Larry who accepts such conveyance and acknowledges that in doing so he accepts all liabilities of the Partnership. Stacy and Scott each warrant that they have not encumbered or otherwise transferred any of their respective 1/400 interest in the Partnership to any party except as same



is hereby assigned and conveyed to Larry.

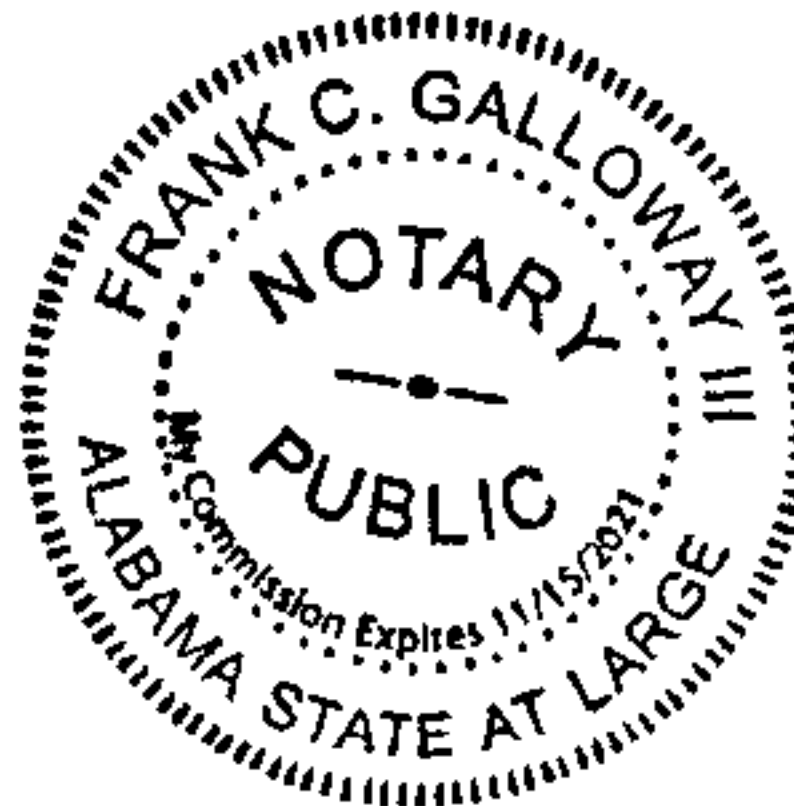

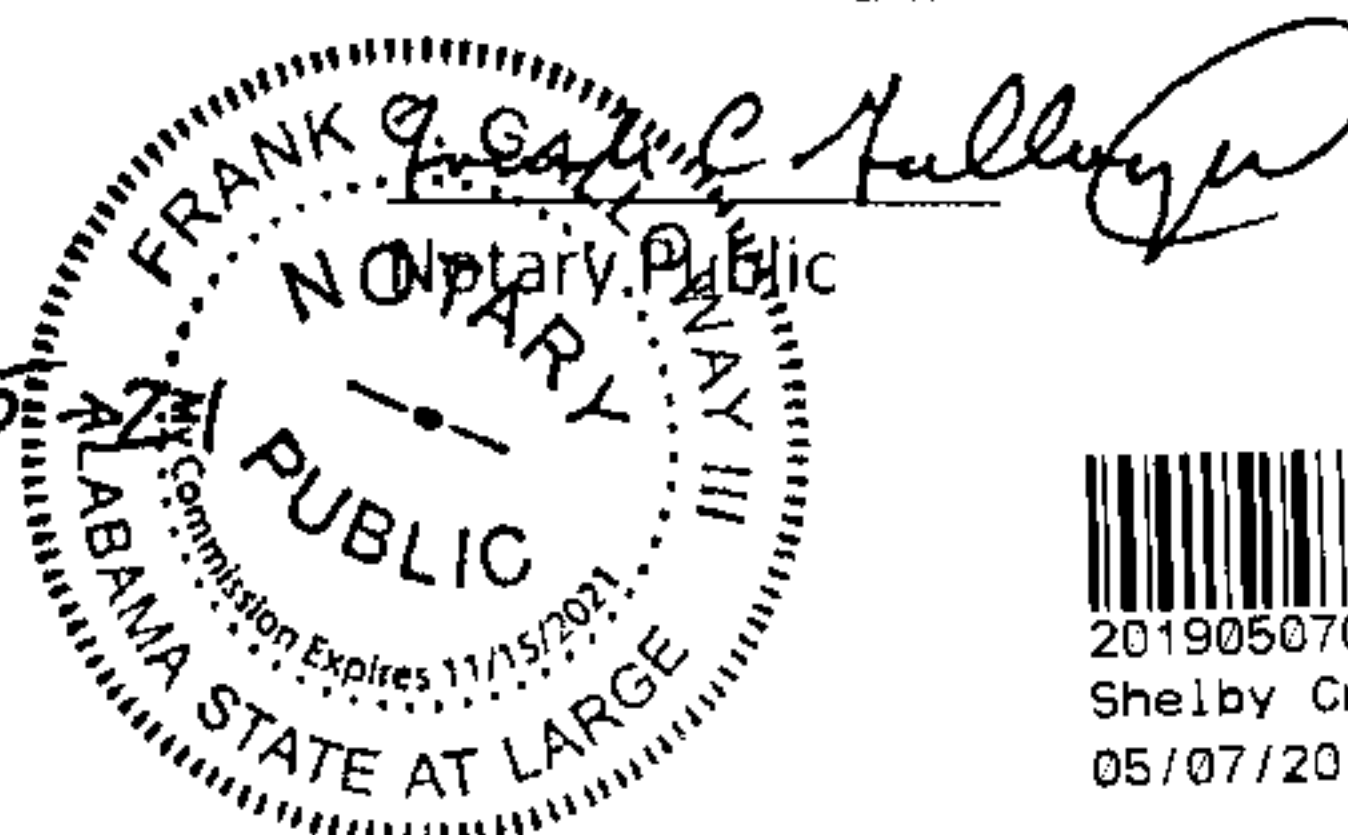
