Ingram, an unmarried woman, (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Ruth Rena Morris (hereinafter grantee, whether one or more), all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama:
