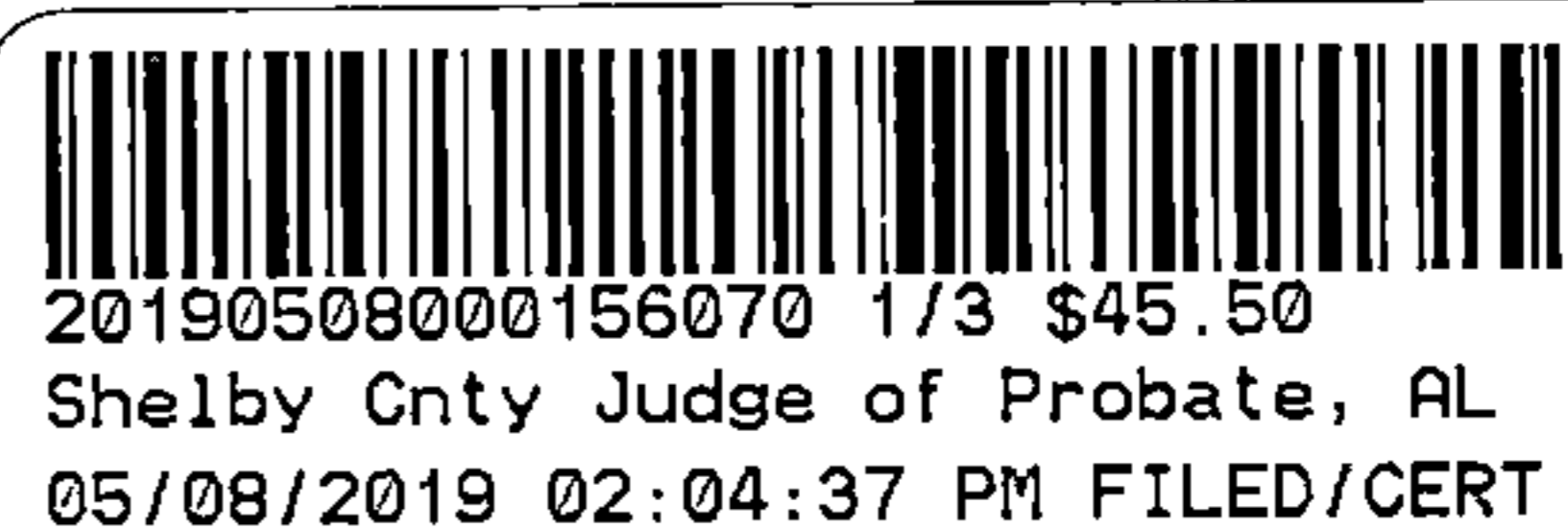


\$383,050.00 of the above consideration is being paid by a mortgage, which is filed simultaneously herewith.



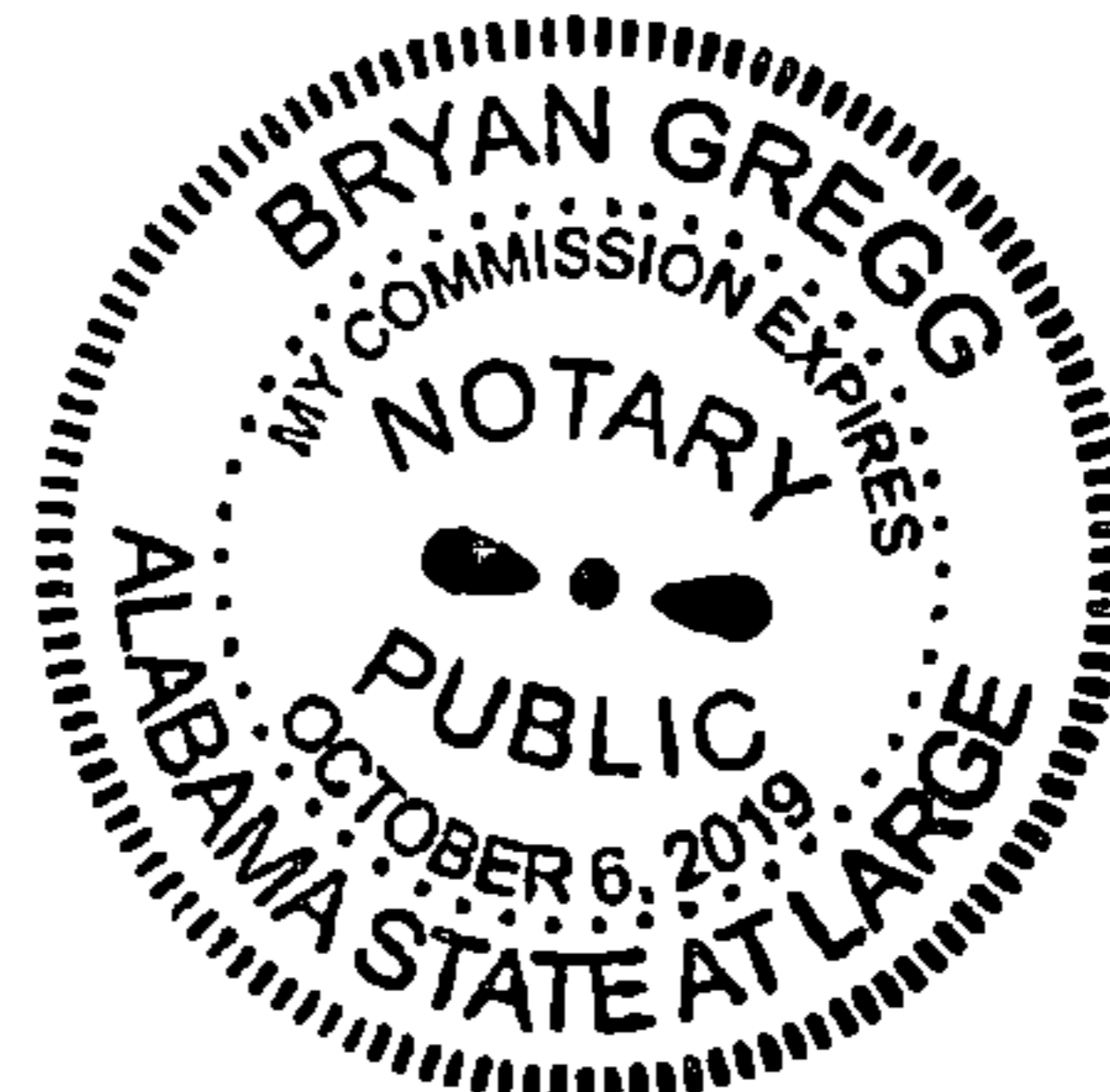
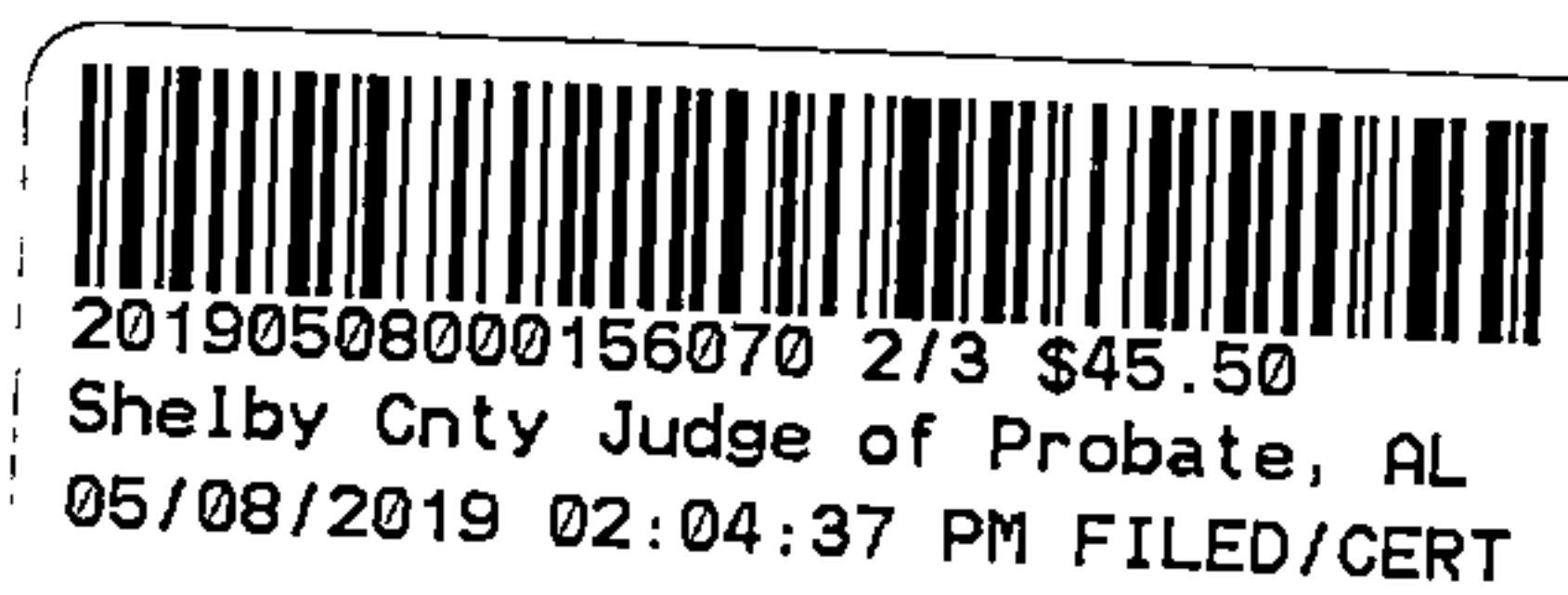


Exhibit "A" Legal Description
