**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**STATE OF ALABAMA

**KNOW ALL MEN BY THESE PRESENTS,**

**On this May 10, 2019**, That for and in consideration of **THREE HUNDRED FORTY THOUSAND AND NO/100 (\$340,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **MARY W. HILLIS, an unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **RUSSELL T. PARKER and MELANIE C. PARKER**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 553, according to the Survey of Eagle Point 5th Sector, as recorded in Map Book 18, Page 138, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2019 and subsequent years not yet due and payable.-
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 18, Page 138.
7. Building setback line of 25 feet reserved from Eagle Crest Road as shown by plat.
8. Restrictions, Covenants and Conditions as set out in Instrument(s) recorded in Inst. #1994-26089.

13. Easement(s) to Alabama Power Company as shown by instrument recorded in Inst. #1995-12811.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


