(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Austin Daniel Milster and Mallory Barnes Milster

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 3, according to the Survey of Heatherwood, Sector 1, as recorded in Map Book 8, page 27, in the Probate Office of Shelby County, Alabama.

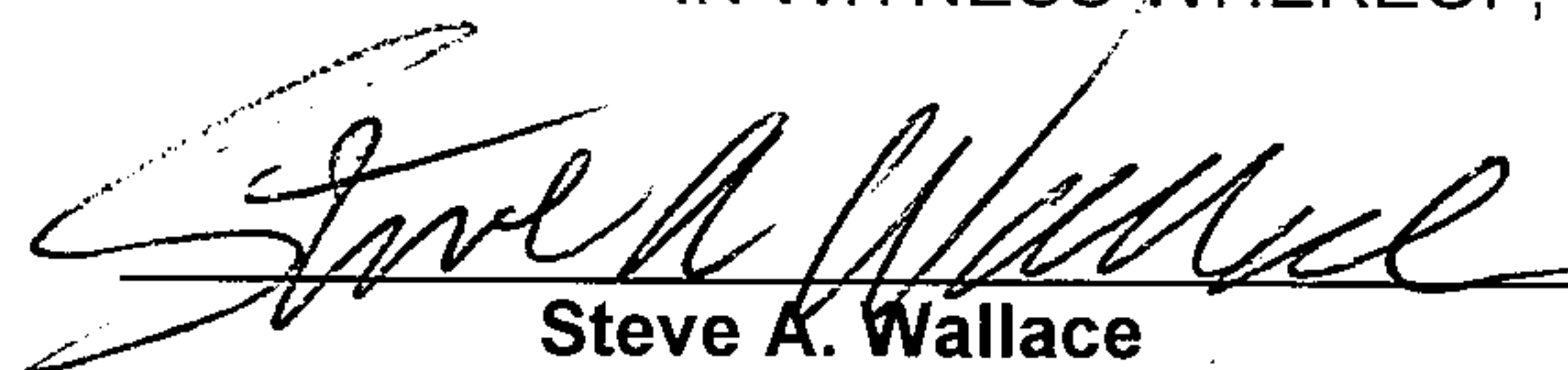
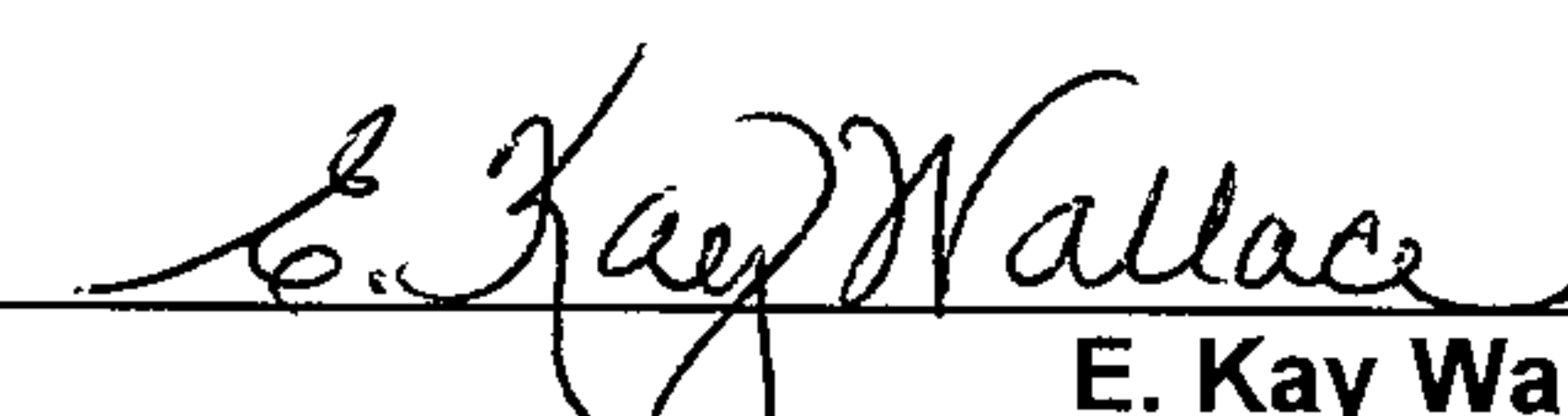
\$422,500.00 of the proceeds come from a mortgage recorded simultaneously herewith.

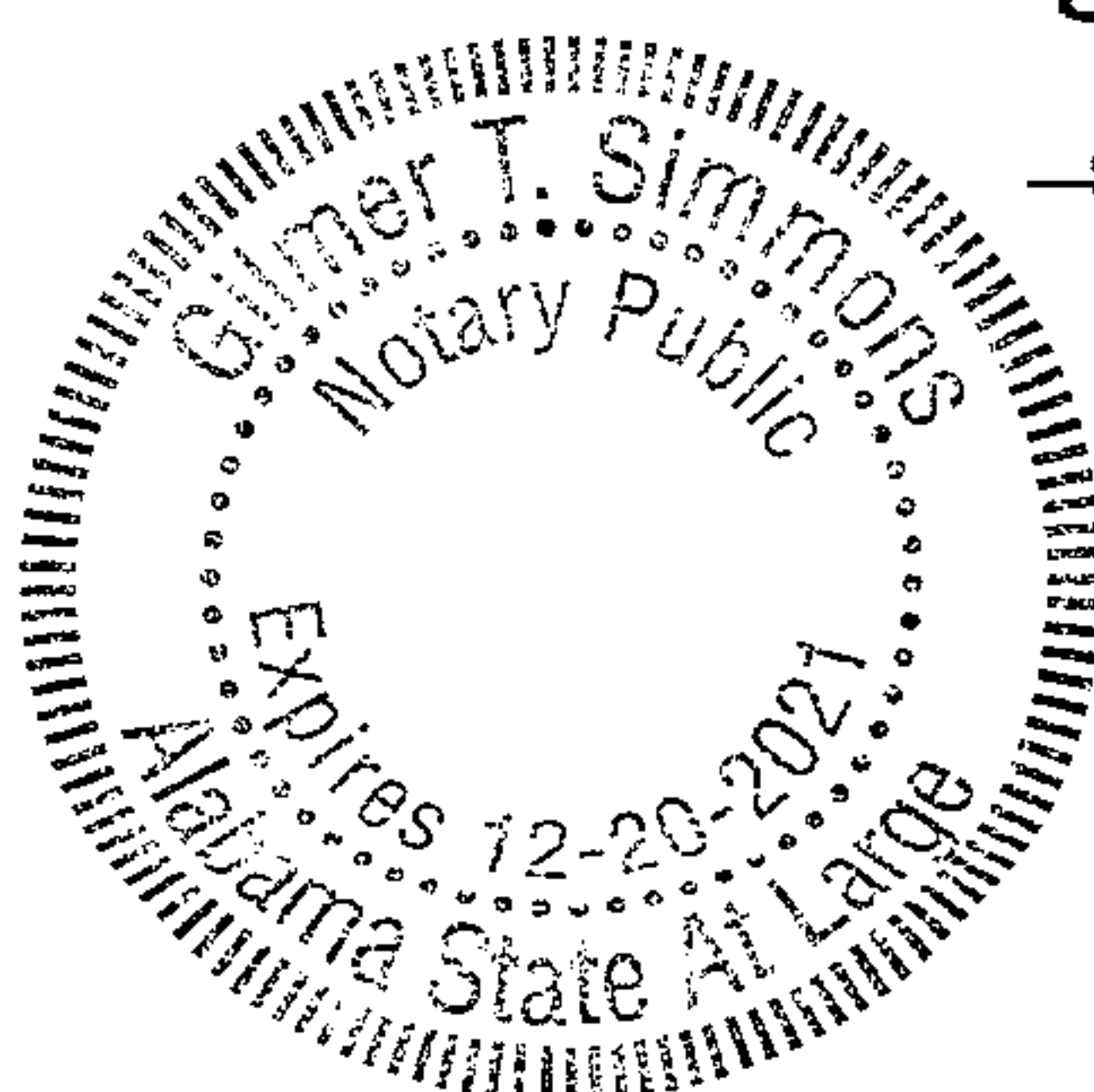

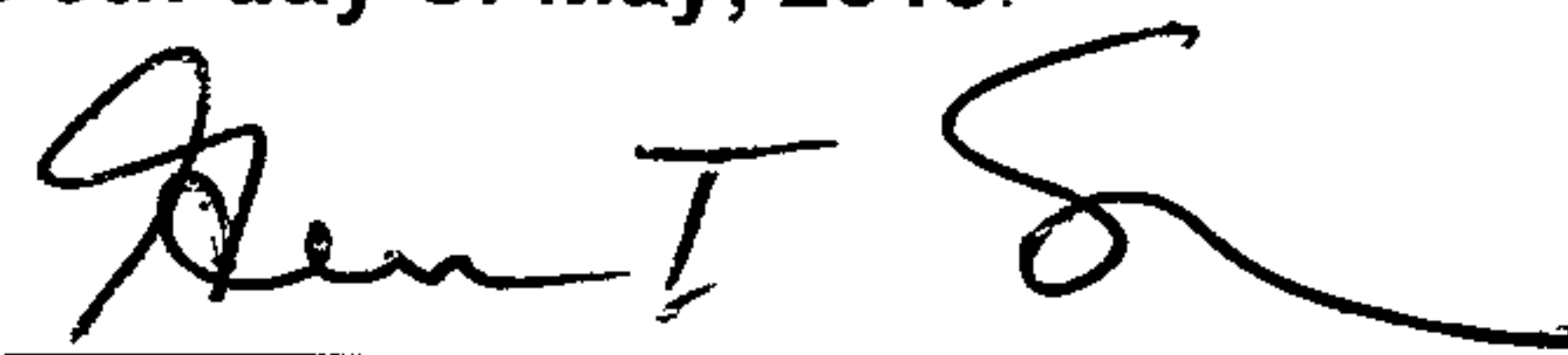

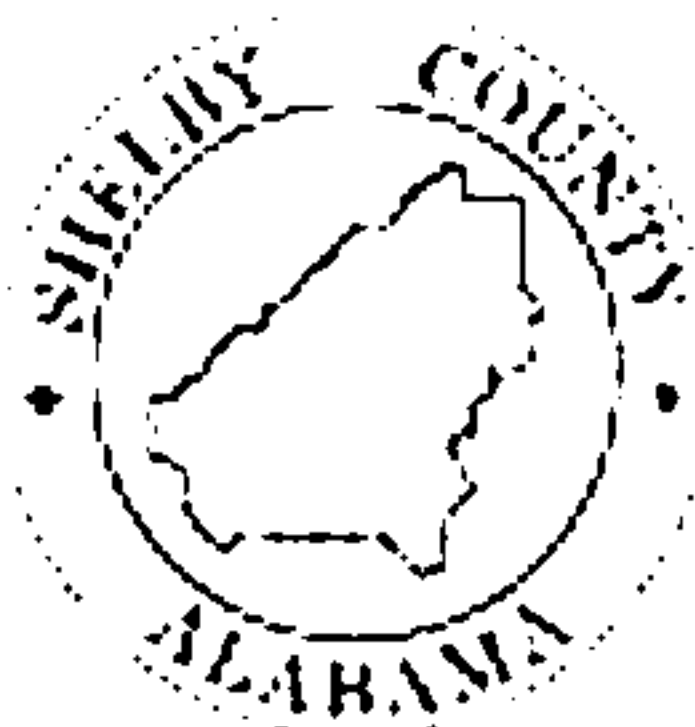
