MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, April 9, 2009, Tina Georgette Hall, Unmarried, Mortgagor, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc., as nominee for Countrywide Bank, FSB, its successors and assigns, which said mortgage is recorded in Instrument No. 20121005000383260 as modified by that certain Modification Agreement in Instrument No. 20130829000353360, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to Nationstar Mortgage LLC d/b/a Mr. Cooper, as transferee, said transfer is recorded in Instrument 20161028000396610, aforesaid records, and Nationstar Mortgage LLC d/b/a Mr. Cooper, is now the holder and owner of said mortgage and debt; and

WHEREAS, on May 20, 2019, the day on which the foreclosure sale was due to be held under the terms of said notice at 11:39 o'clock am, between the legal hours of sale, said foreclosure was duly and properly conducted and Nationstar Mortgage LLC d/b/a Mr. Cooper did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Pelham, Alabama, the property hereinafter described; and

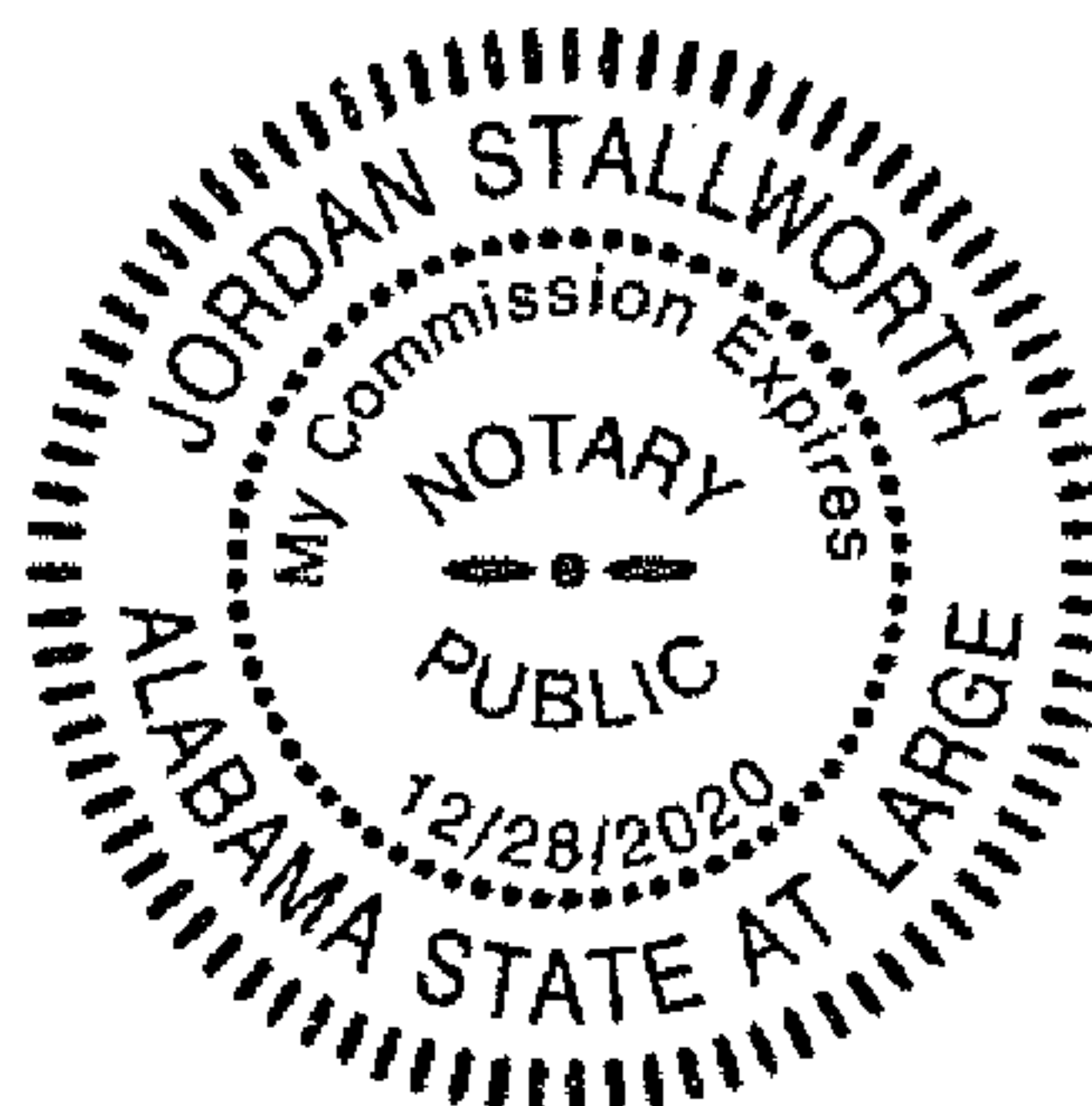
