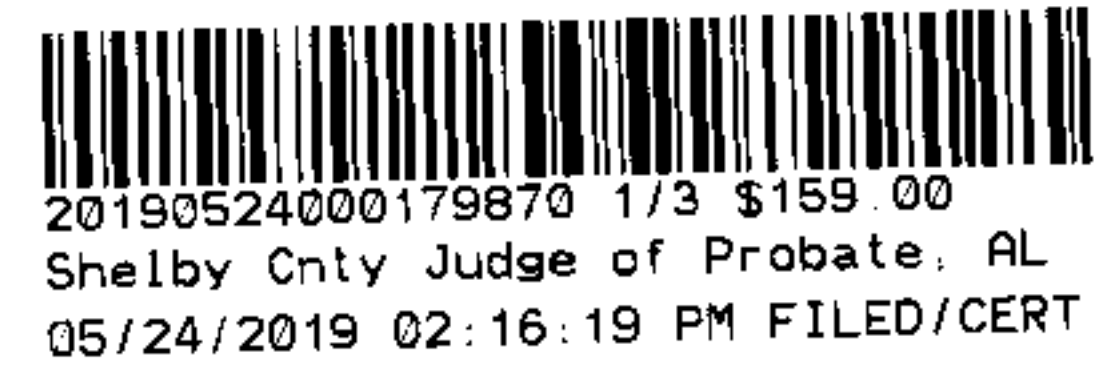


**Articles of Organization
of
Goliath Lending, L.L.C.**



We the undersigned natural persons of age nineteen years or more, acting as organizers of a limited liability company under the Limited Liability Company Act of the State of Alabama, hereby adopt the following Articles of Organization for the limited liability company:

ARTICLE ONE

The name of the limited liability company is Goliath Lending, L.L.C.

ARTICLE TWO

The limited liability company is organized for the purpose of operating a retail and pawn establishment and other similarly related services and for the purpose of transacting any lawful business for which a limited liability company may be organized.

ARTICLE EIGHT

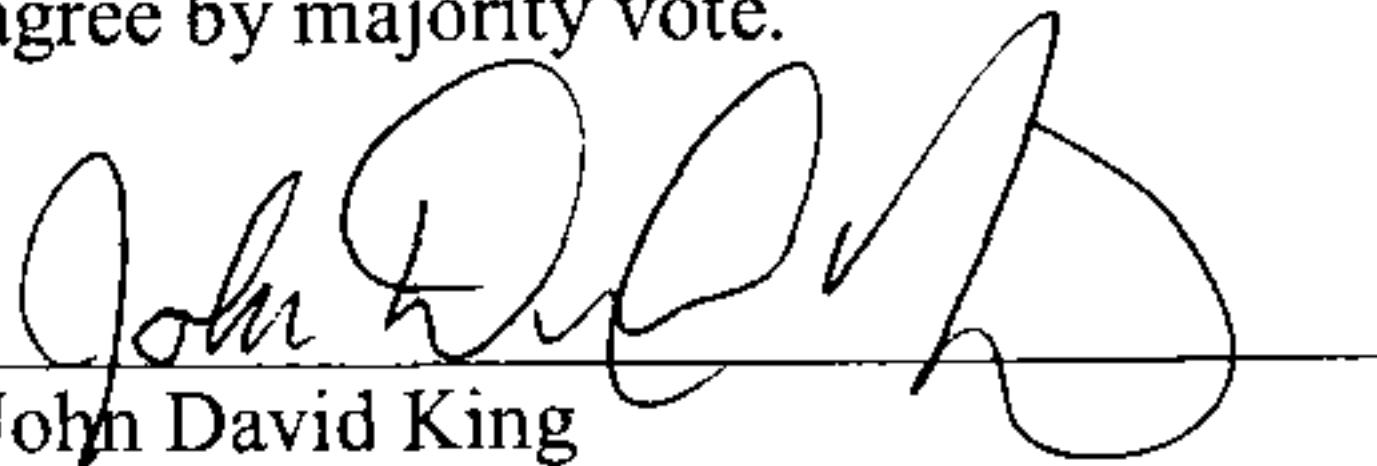
The name and address of each organizer of the limited liability company is show below.

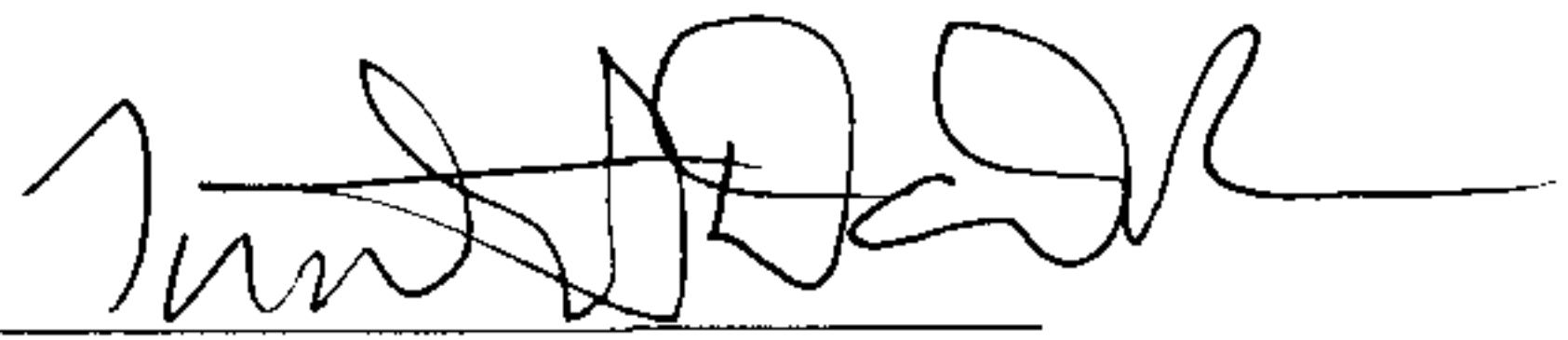

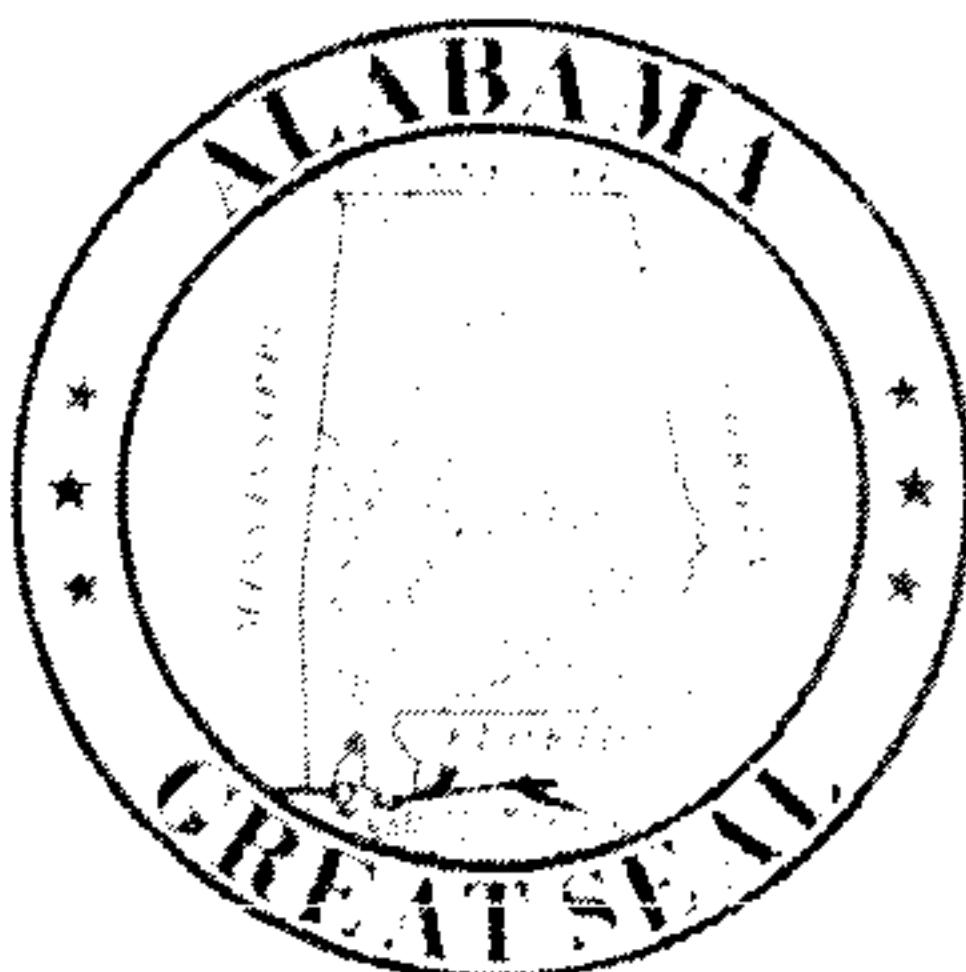
