Registered Office; Registered Agent**

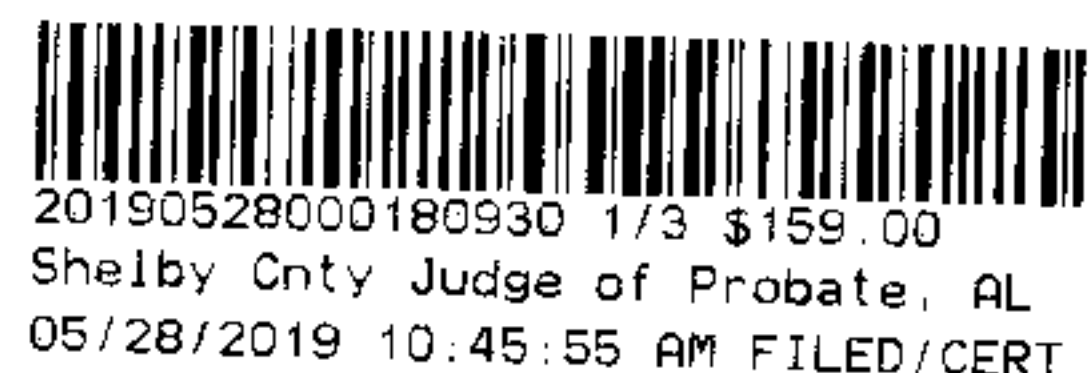

Organizer**


