KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of July, 2012, Thelma E. Peeples, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20120727000272270, said mortgage having subsequently been transferred and assigned to PennyMac Loan Services, LLC, by instrument recorded in Instrument number 20190329000099930, in the aforesaid Probate Office ("Transferee"); and

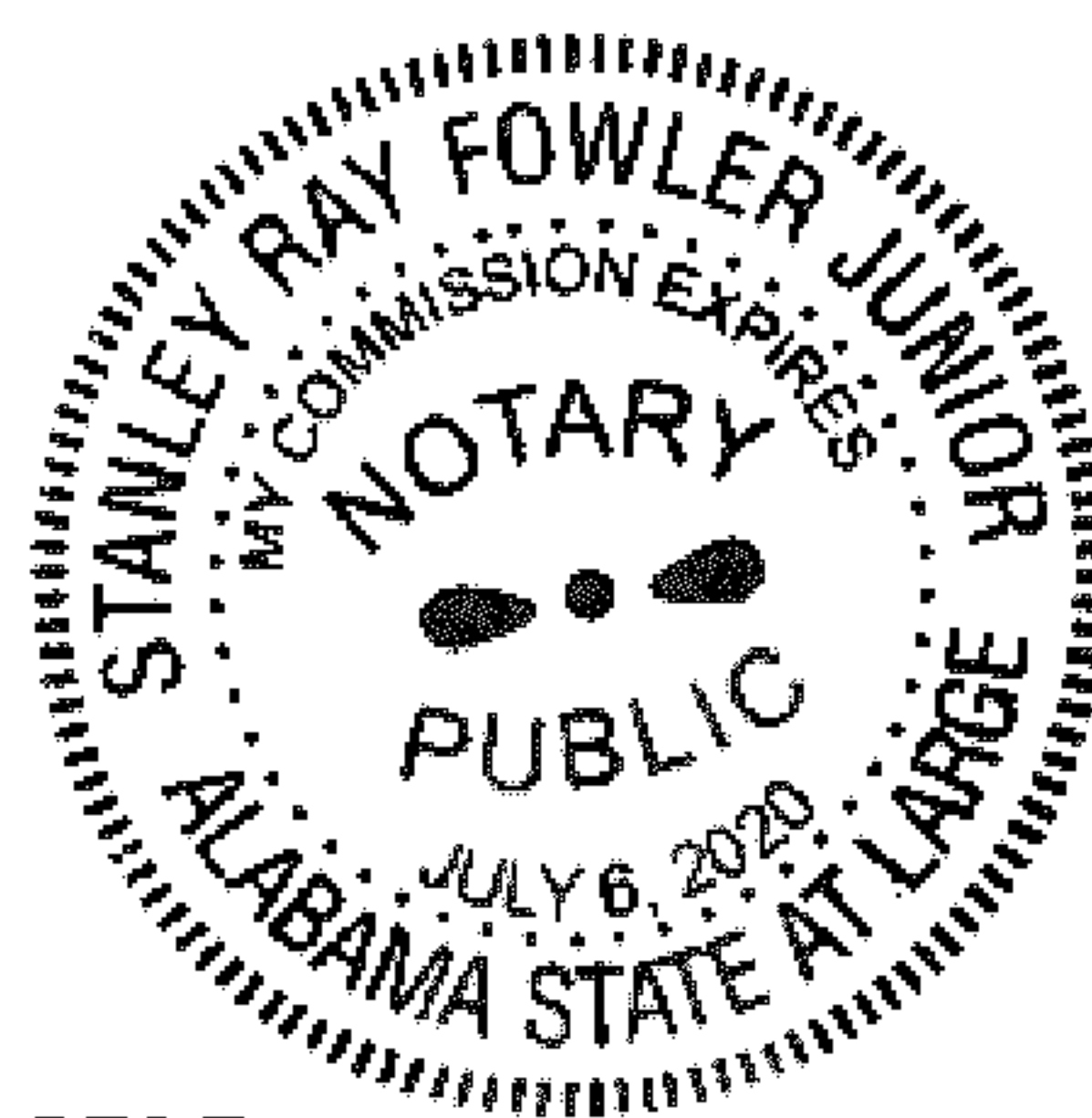
