ARTICLE EIGHT

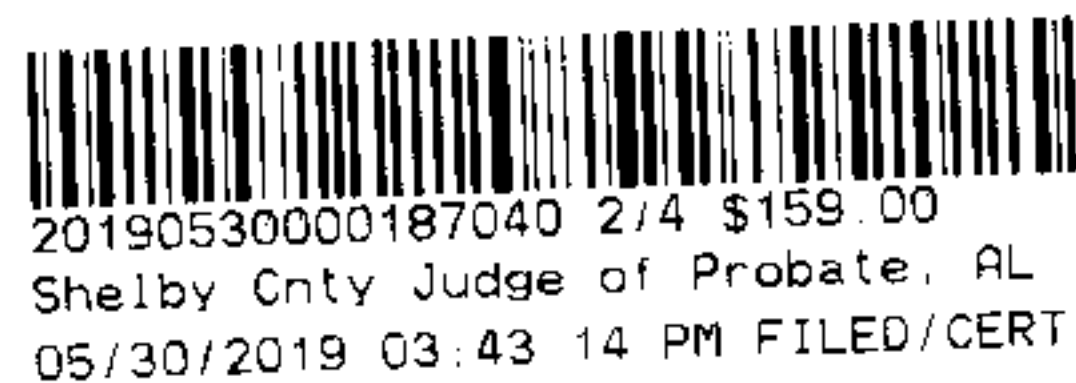

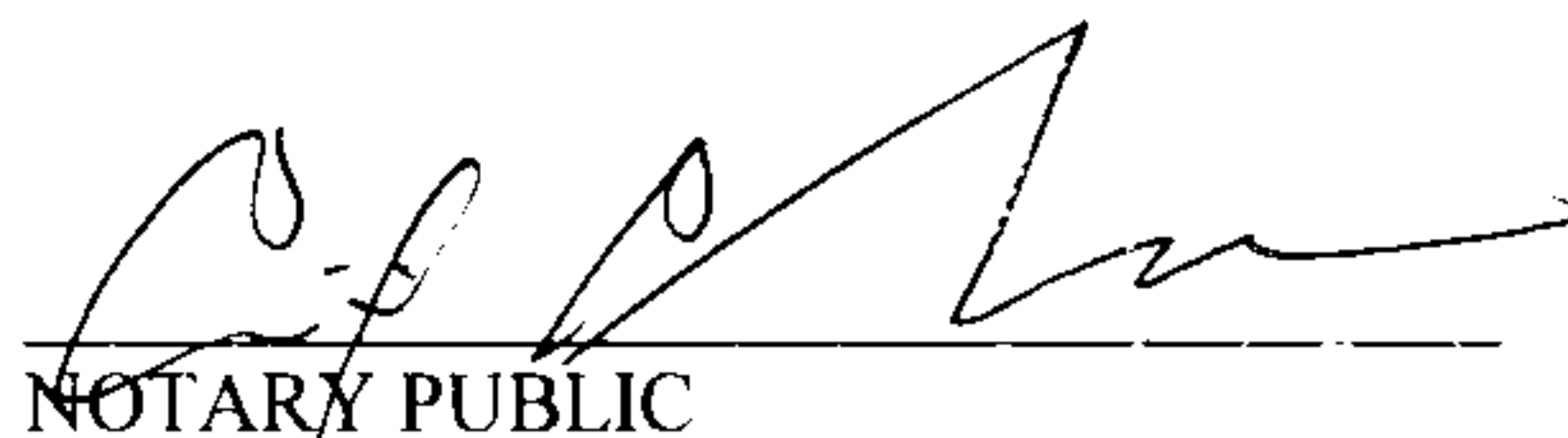
