**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

That for and in consideration of **TWO HUNDRED SEVENTY EIGHT THOUSAND NINE HUNDRED AND NO/100 (\$278,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **CHRISTOPHER GOLSER, an unmarried man, and SARA R. GOLSER, an unmarried woman**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **JOHN RANDALL CARROLL and JULIE LYNNE MCKENZIE**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:
