Know All Men by These Presents: That in consideration of **Three Hundred Forty-Nine Thousand Nine Hundred and no/100 Dollars (\$349,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **DERRICK M. 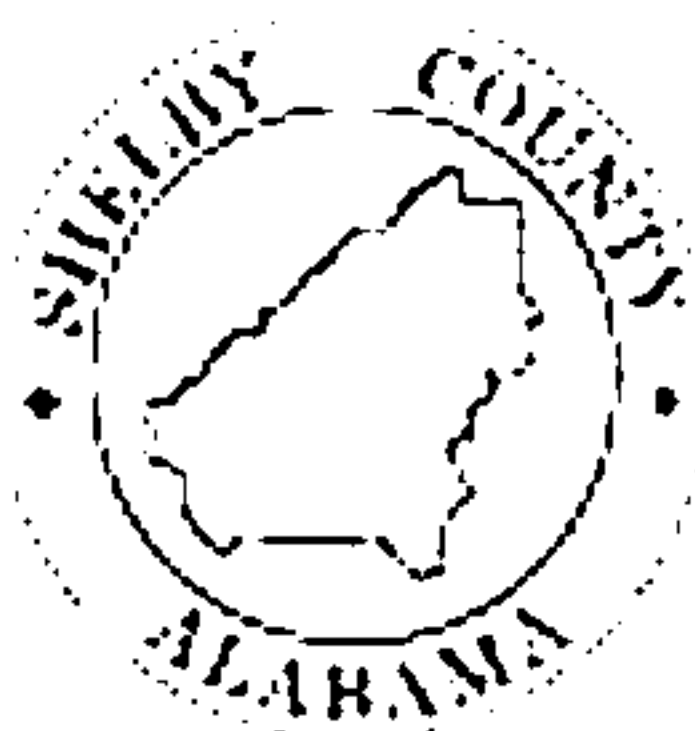
