This Assignment is made with respect to the following facts:


- A. Assignor has as of the date hereof conveyed to Assignee the real property described on Exhibit A attached hereto and made a part hereof (the "Real Property").

- 4. Notification of Assignment. Assignor covenants and agrees to deliver a signed statement to the tenant under the Lease, notifying the tenant that the Lease has been assigned.
- Binding Effect of this Assignment. This Assignment shall be binding upon and inure to the benefit of Assignor, Assignee, and their respective successors and assigns.
