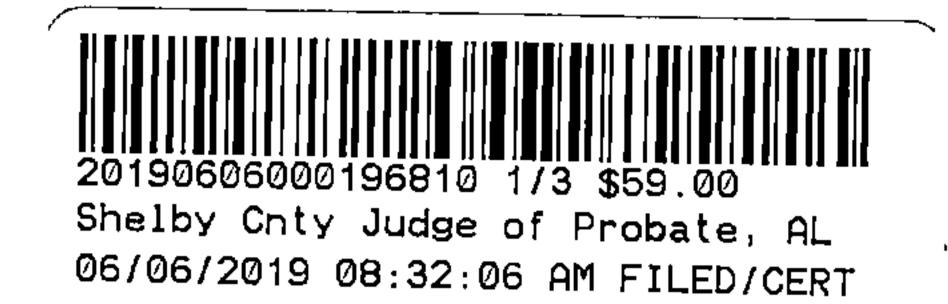

WARRANTY DEED
