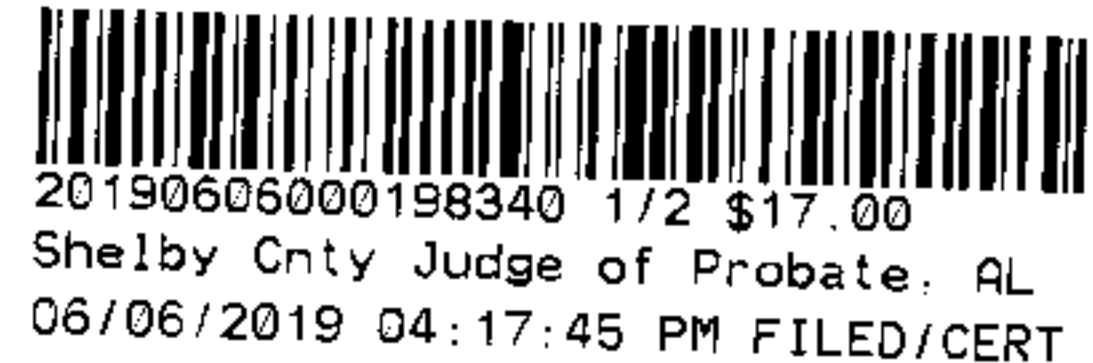
8. The Trustee may conduct business on behalf of the trust without the consent of any other person or entity.

13. The trust agreement provides that a third party may rely on this Affidavit of Trust in lieu of a copy of the trust agreement. It further exonerates third parties from any liability for acts or omissions in reliance on this Affidavit of Trust, and for the application that the Trustee makes of funds or other property delivered to the Trustee.

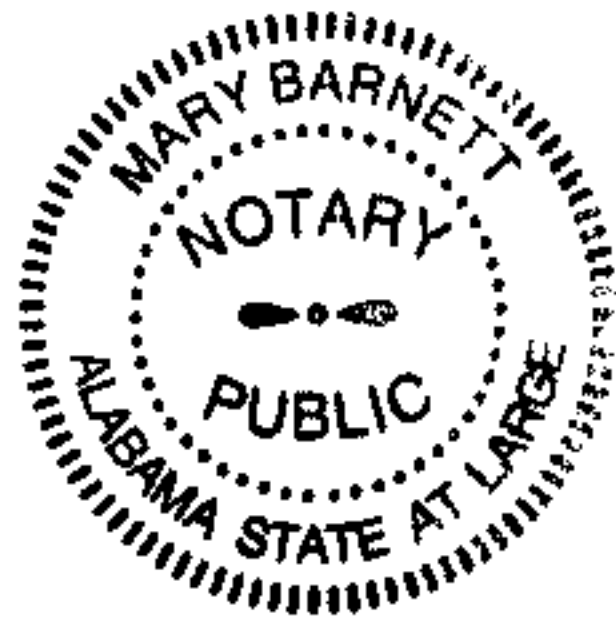
