Property constitutes no part of the homestead of the grantors herein, or their spouses.

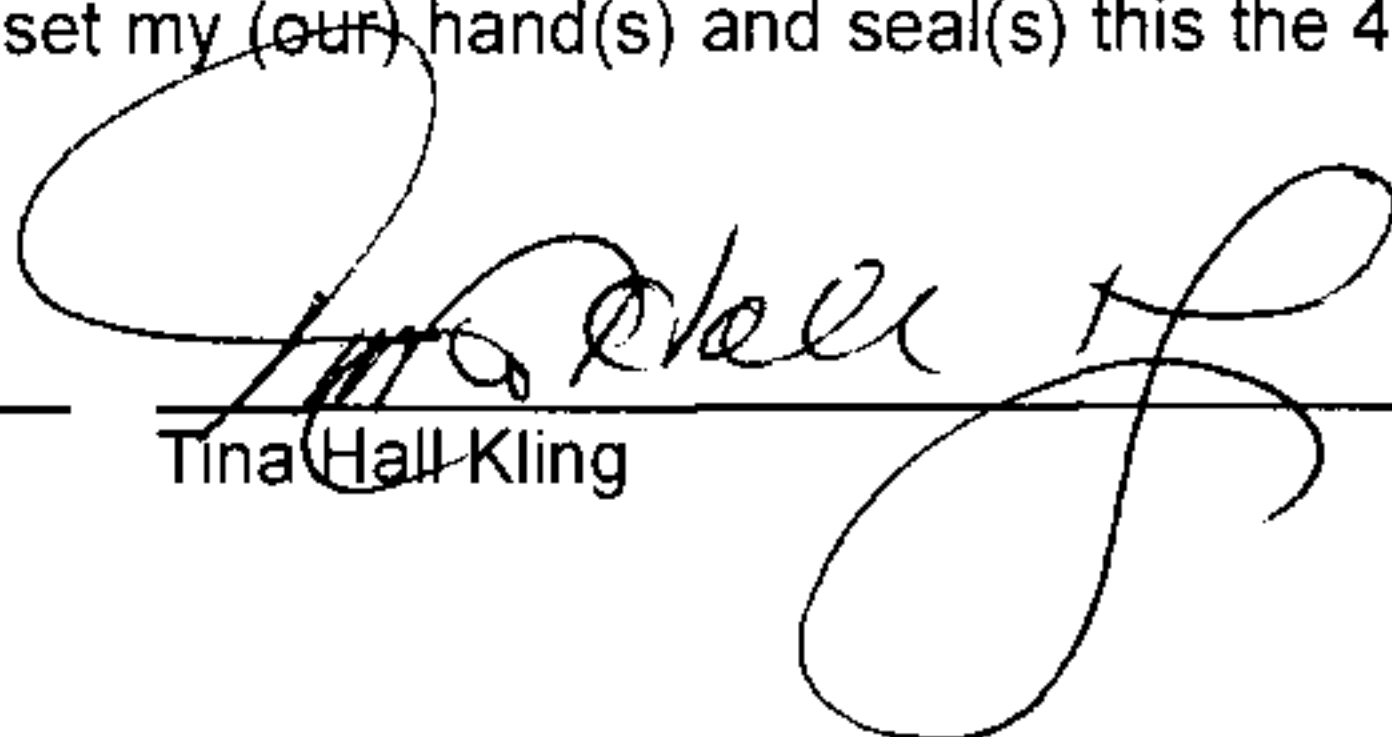

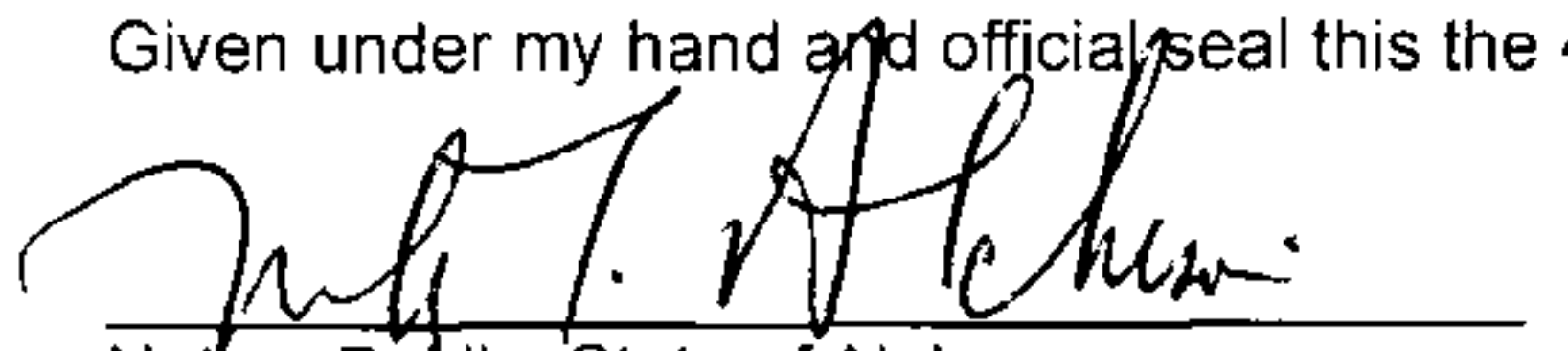

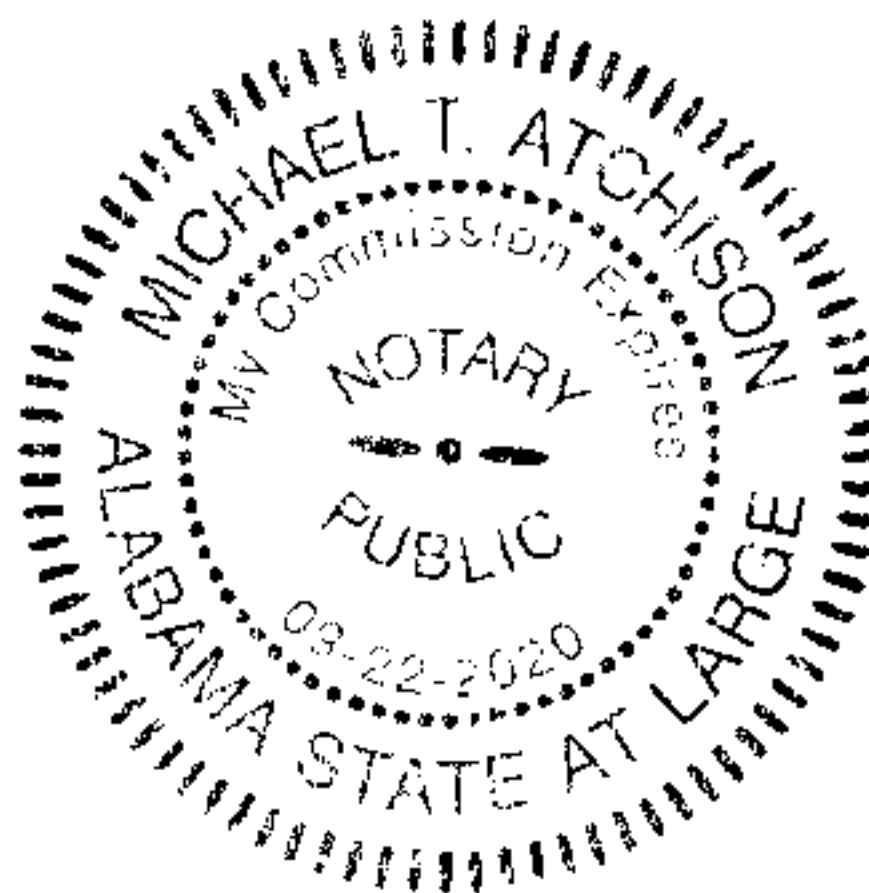
