Subject to Easements, Restrictions and rights of way of record.



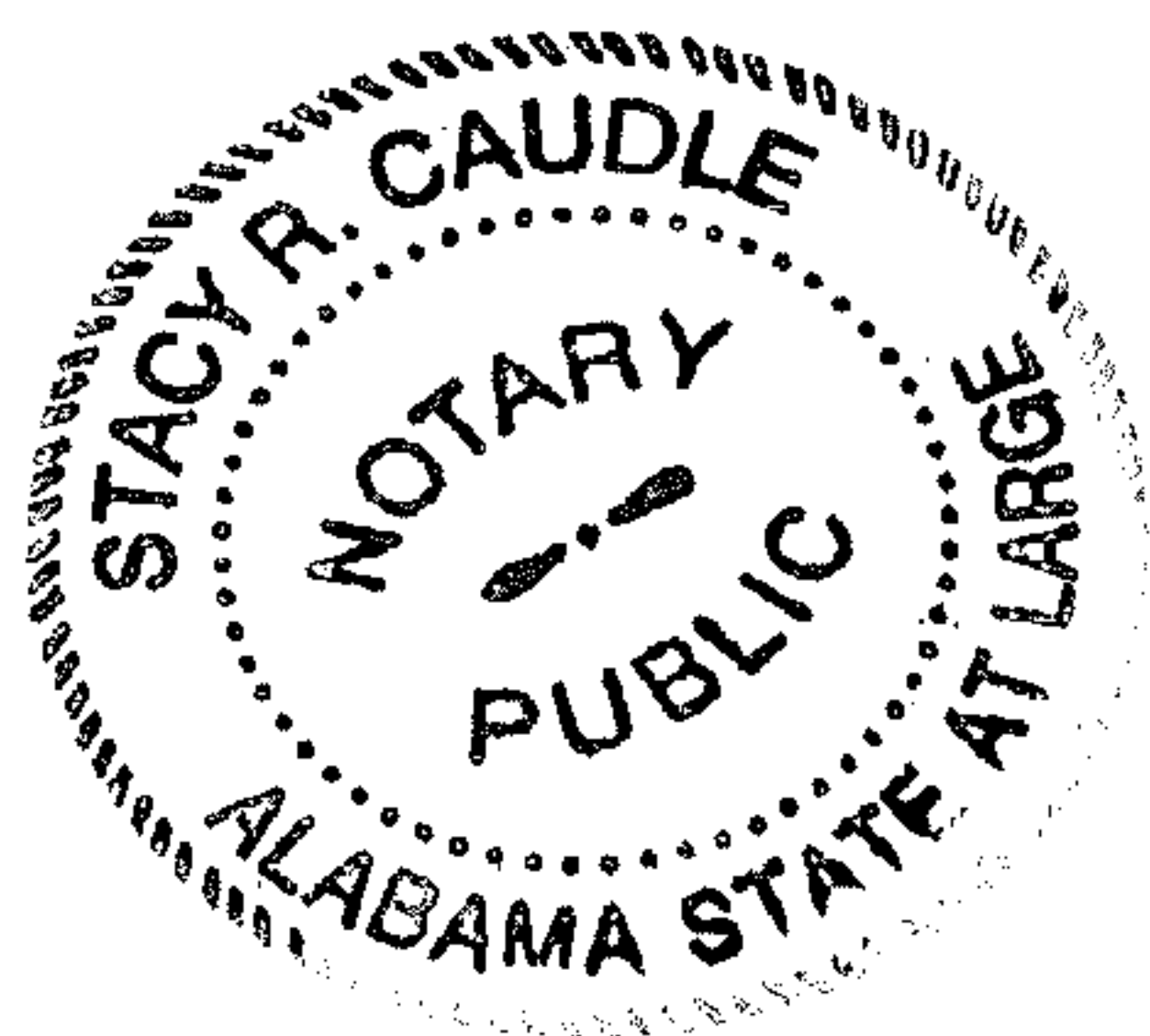
