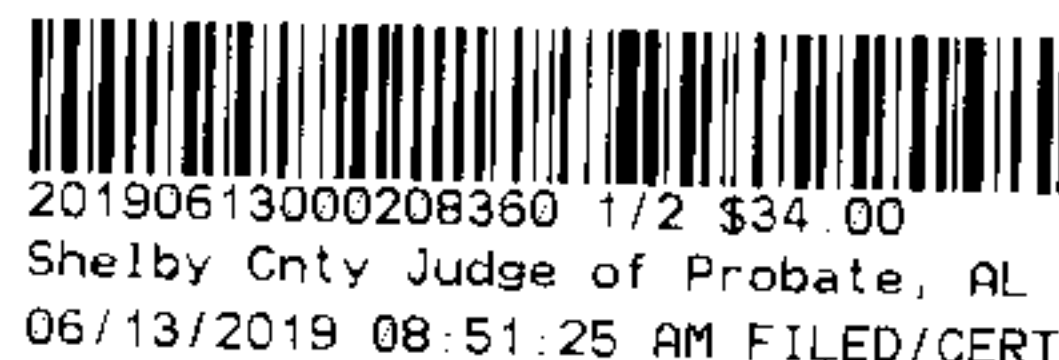

Dodson, a single woman and Mary Kay Messina**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Thomas D. Hopkins, III and Regina A. Hopkins**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

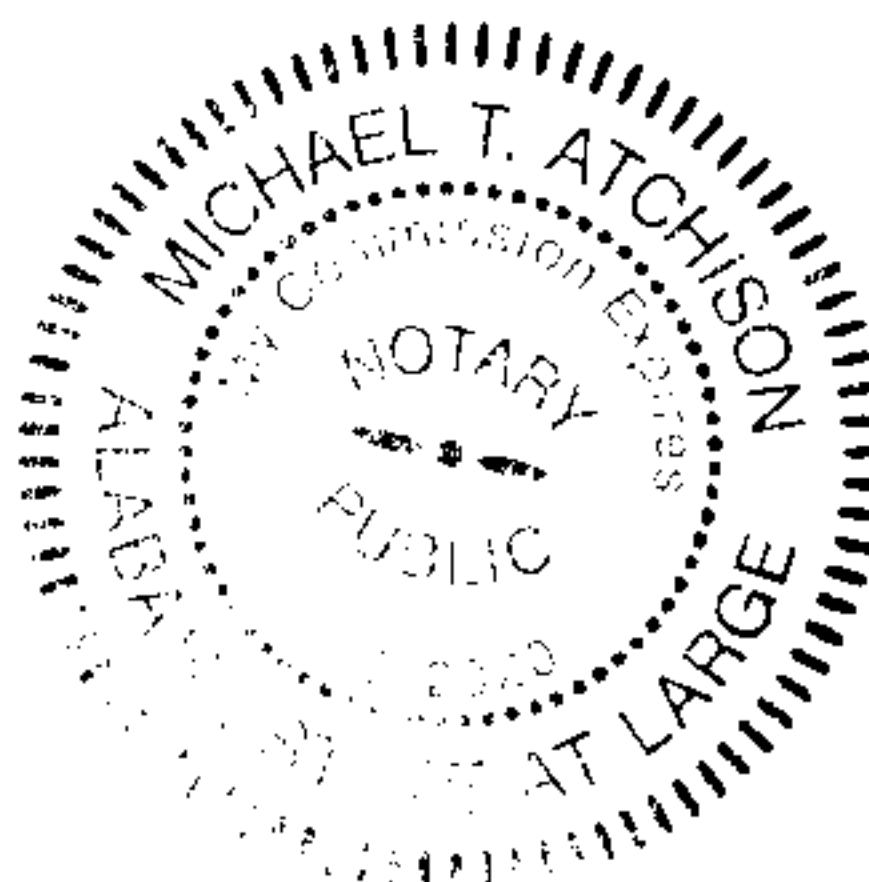
