**RIGHT OF WAY DEED
FOR PERMANENT EASEMENT**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **Nine Thousand Two Hundred** dollar(s) cash in hand paid, the receipt of which is hereby acknowledged, as I (we), the undersigned grantor(s), **Dwight C. and Gwendolyn D. Edwards** have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County, a political subdivision of the State of Alabama, a permanent easement and right of way including all right, title and interest in and to all timber growing or at any time located within the right of way and easement limits, upon the land hereinafter described, together with the right to locate or relocate utilities, and to enter upon such described land and grade, level, fill, drain, pave, build, maintain, repair, and rebuild a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary, on, over and across such right of way easement. The easement and right of way hereby granted is more particularly located and described as follows:

A parcel of land situated in the Southeast one-quarter of the Northeast one-quarter of Section 13, Township 20 South, Range 4 East, Shelby County, Alabama, being more particularly described as follows:

Commence at a found RC Farmer capped rebar being the Northwest corner of said quarter-quarter; thence run North 87 Degrees 54 Minutes 50 Seconds East along the North line of said quarter-quarter for a distance of 835.28 feet; thence leaving said North line, run South 02 Degrees 05 Minutes 10 Seconds East for a distance of 426.98 feet to the POINT OF BEGINNING; thence run North 53 Degrees 01 Minutes 14 Seconds East for a distance of 91.66 feet; thence run South 11 Degrees 56 Minutes 49 Seconds East for a distance of 29.91 feet; thence run South 45 Degrees 14 Minutes 10 Seconds West for a distance of 88.02 feet; thence run North 25 Degrees 06 Minutes 25 Seconds West for a distance of 39.88 feet to the POINT OF BEGINNING. Said parcel contains 2,895 square feet or 0.066 acres more or less.

And as shown on the right of way map of record in Shelby County Highway Department, a copy of which is also deposited in the office of the Judge of Probate as an aid to persons and entities interested therein, and as shown on the Property Sketch attached hereto and made a part hereof.

TO HAVE AND TO HOLD, the said easement and right of way including all right, title, and interest in and to such timber aforementioned unto Shelby County, a political subdivision of the State of Alabama, and unto its successors and assigns forever.

And the said grantor(s) hereby covenant(s) with Shelby County, a political subdivision of the State of Alabama, that I (we) am (are) lawfully seized and possessed of the afore-described tract or parcel of land; that I (we) have a good and lawful right to sell and convey it; that it is free from all encumbrances; and that I (we) will warrant and forever defend the title and quiet possession thereto against the lawful claims of all persons whomsoever.

As a further consideration for the payment of the purchase price, above stated, I (we) hereby release Shelby County, a political subdivision of the State of Alabama, its employees and officials, from all claims for damage, from whatsoever cause, present or prospective, incidental or consequential, to the exercise of any of the rights herein granted.

The grantor hereby grants permission, with right of ingress to and egress from, grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right of way.

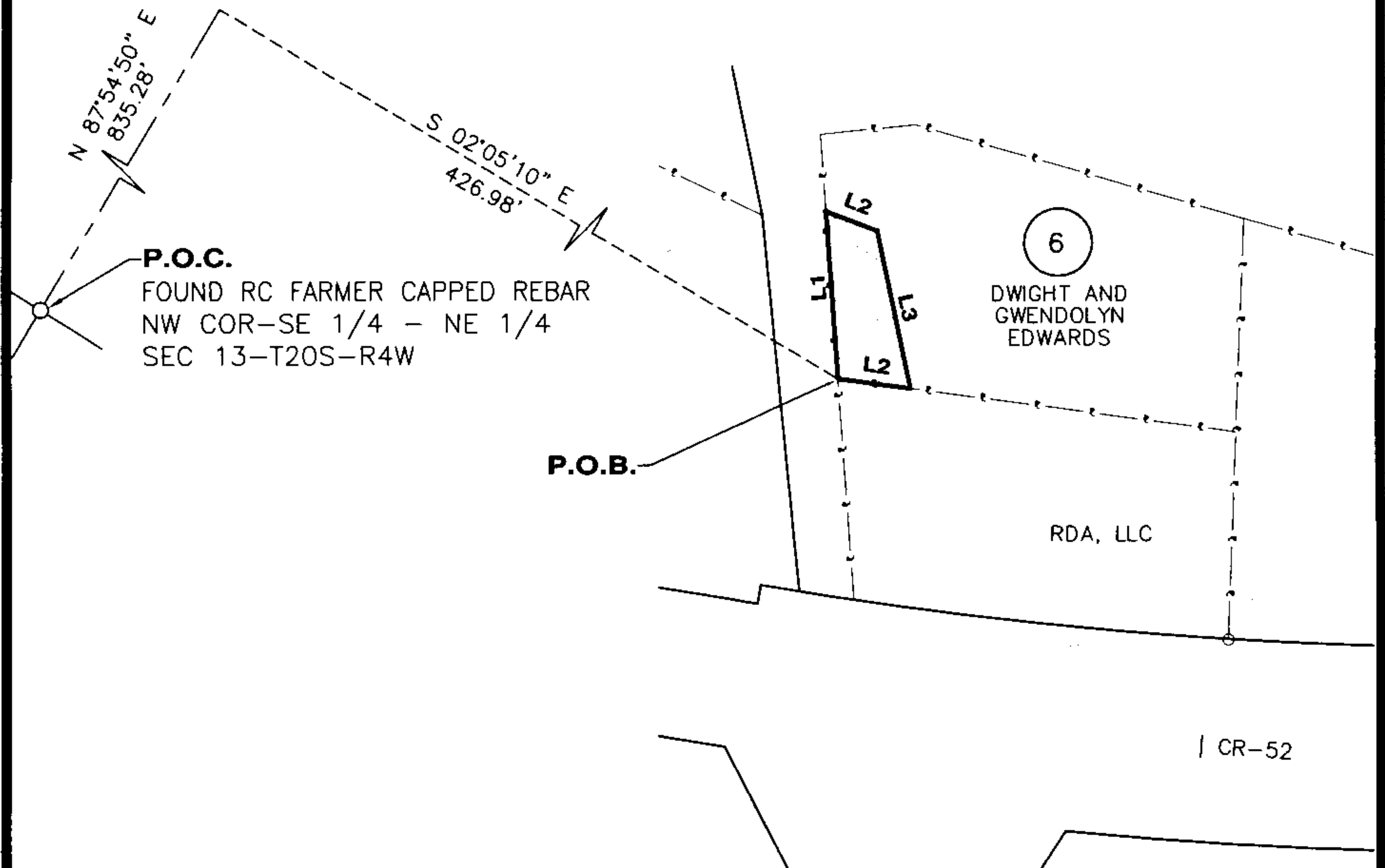

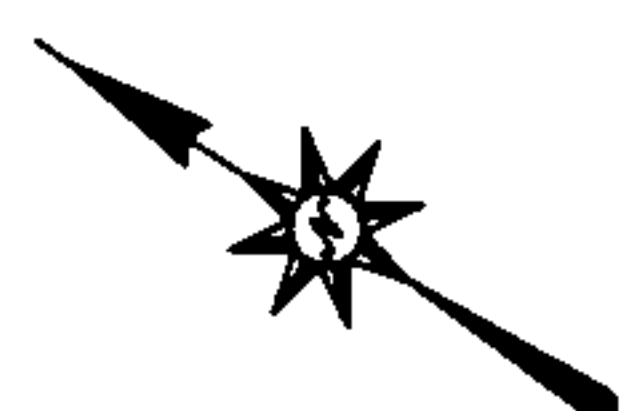
