RIGHT OF WAY DEED FOR PERMANENT EASEMENT

Edwards have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County, a political subdivision of the State of Alabama, a permanent easement and right of way including all right, title and interest in and to all timber growing or at any time located within the right of way and easement limits, upon the land hereinafter described, together with the right to locate or relocate utilities, and to enter upon such described land and grade, level, fill, drain, pave, build, maintain, repair, and rebuild a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary, on, over and across such right of way easement. The easement and right of way hereby granted is more particularly located and described as follows:

A parcel of land situated in the Southeast one-quarter of the Northeast one-quarter of Section 13, Township 20 South, Range 4 East, Shelby County, Alabama, being more particularly described as follows:

Commence at a found RC Farmer capped rebar being the Northwest corner of said quarter-quarter; thence run North 87 Degrees 54 Minutes 50 Seconds East along the North line of said quarter-quarter for a distance of 835.28 feet; thence leaving said North line, run South 02 Degrees 05 Minutes 10 Seconds East for a distance of 426.98 feet to the POINT OF BEGINNING; thence run North 53 Degrees 01 Minutes 14 Seconds East for a distance of 91.66 feet; thence run South 11 Degrees 56 Minutes 49 Seconds East for a distance of 29.91 feet; thence run South 45 Degrees 14 Minutes 10 Seconds West for a distance of 88.02 feet; thence run North 25 Degrees 06 Minutes 25 Seconds West for a distance of 39.88 feet to the POINT OF BEGINNING. As a further consideration for the payment of the purchase price, above stated, I (we) hereby release Shelby County, a political subdivision of the State of Alabama, its employees and officials, from all claims for damage, from whatsoever cause, present or prospective, incidental or consequential, to the exercise of any of the rights herein granted.

The grantor hereby grants permission, with right of ingress to and egress from, grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right of way.

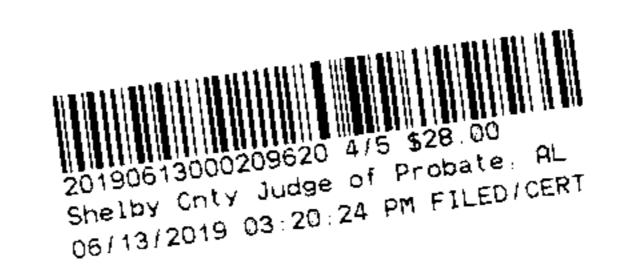

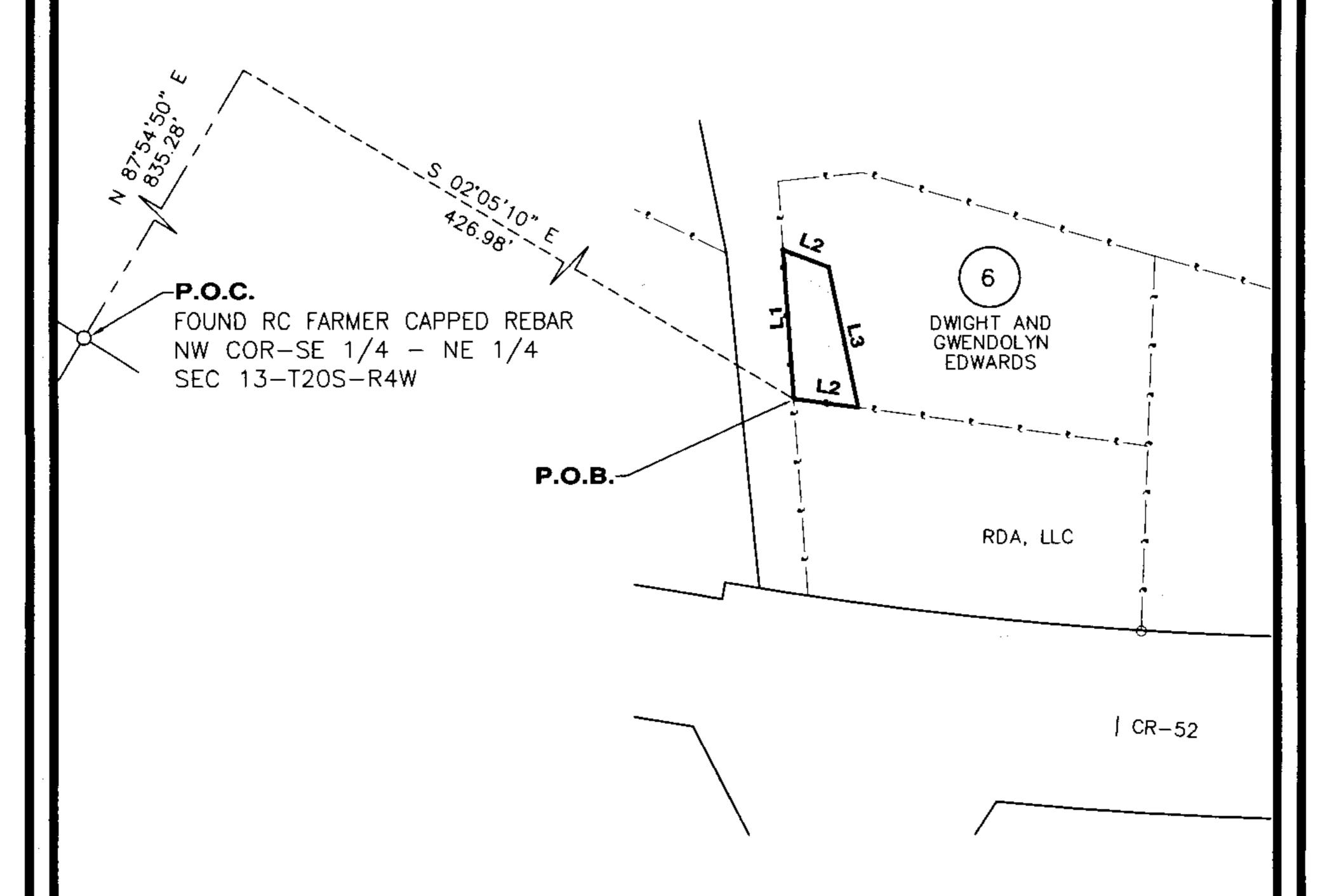
