**SPECIAL WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

WTNESSETH: That the said Grantor, for and in consideration of the sum of One Hundred Thirty Thousand dollars & no cents (\$130,000.00), cash in hand paid and other good and valuable consideration, the receipt of which is hereby acknowledged, have this day given, granted, bargained, sold, conveyed and confirmed and do by these presents give, grant, bargain, sell, convey and confirm unto the said Grantee following described real estate located in Shelby County, Alabama:

LOT 23, ACCORDING TO THE FINAL PLAT OF SOMERSET PHASE 2, AS RECORDED IN MAP BOOK 32, PAGE 142, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

This property does not constitute the homestead of the Grantor(s).

\$132,795.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

This property is sold as is and grantor only warrants title from the time grantor obtained title until the date grantor conveys its interest in the aforesaid property to the grantee.

TO HAVE AND TO HOLD to the said Grantees for and during their joint lives as joint tenants and upon the death of either of them, then to the survivorship of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

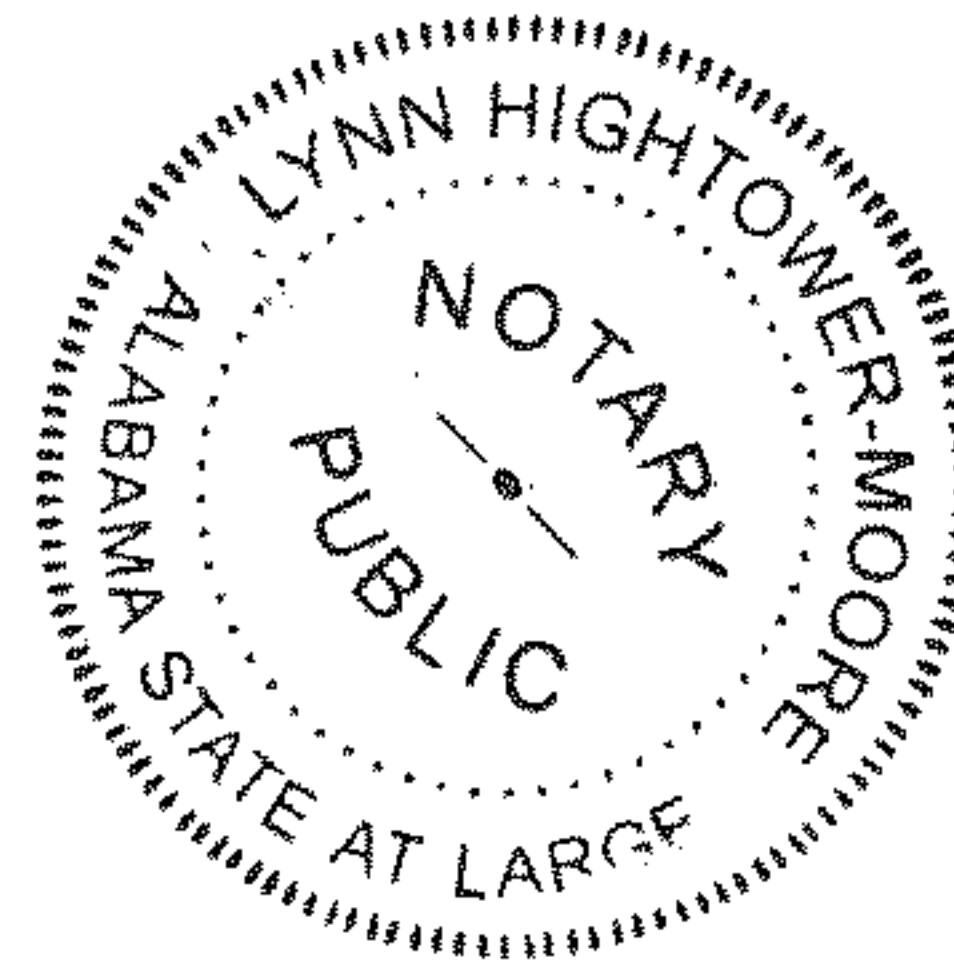

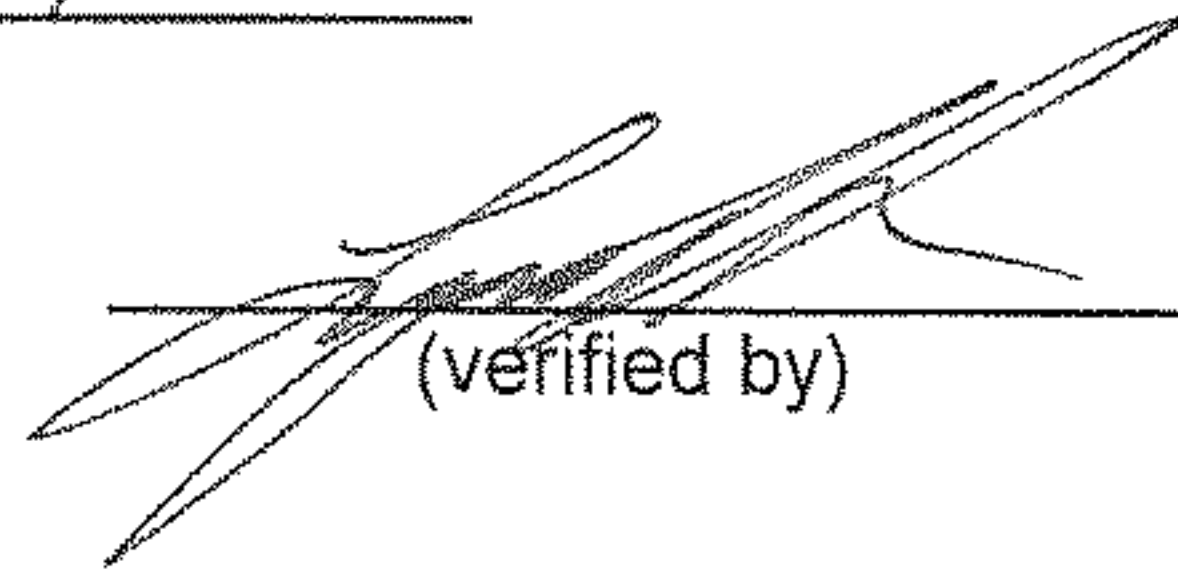

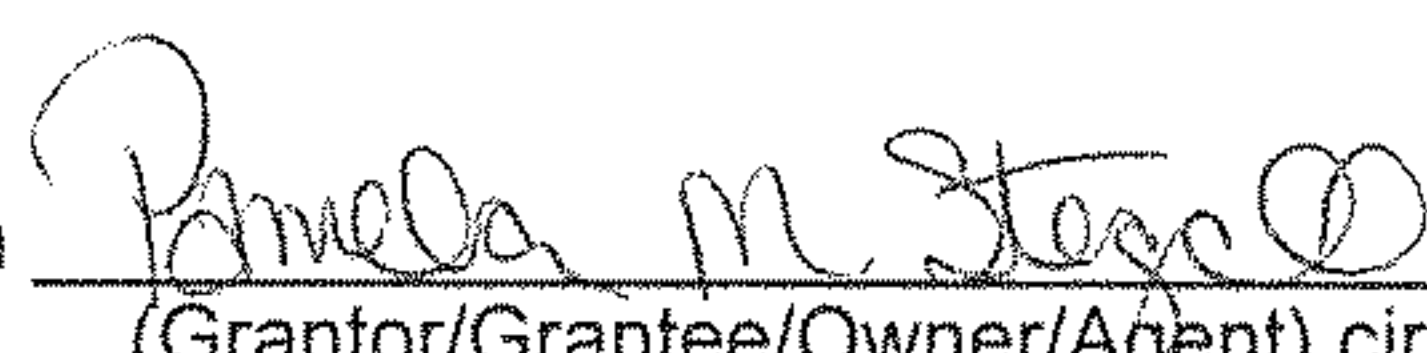
