KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of July, 2005, Patricia Toney, unmarried, executed that certain mortgage on real property hereinafter described to First Franklin a Division of Nat. 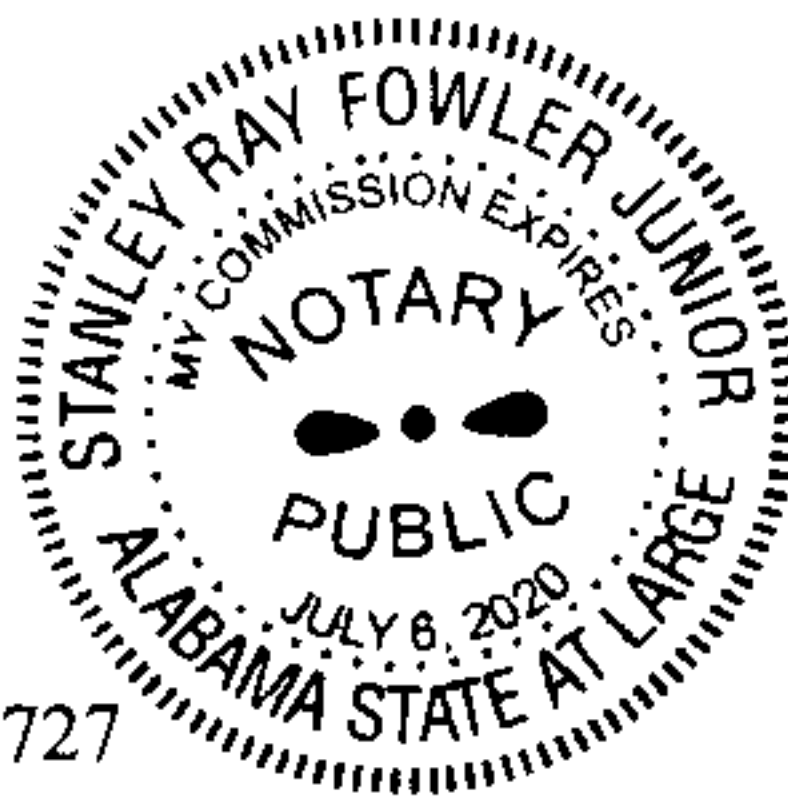
