Know all men by these presents, that for and in consideration of One Hundred Nineteen Thousand and No/100 Dollars (\$119,000.00) and other good and valuable consideration in hand paid to BBVA USA, an Alabama banking corporation, f/k/a Compass Bank (hereinafter referred to as "Grantor") by Harry A. Burrell (hereinafter referred to as "Grantee") the receipt and sufficiency of which are acknowledged hereby, Grantor does by these presents grant, bargain, sell and convey unto the said Grantee, Harry A. Burrell, his heirs and assigns, the following described real estate situated in Shelby County, Alabama, (the "Property"), together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining:

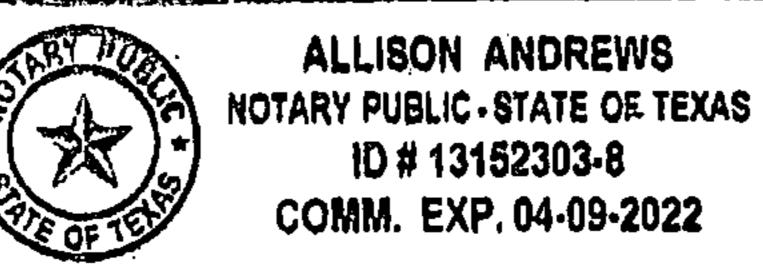
