**CERTIFICATE OF FORMATION
OF
MAY & STUCKEY, LLC**

The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Law of 2014, Code of Alabama (1975) Title 10A, Chapter 1 to the extent applicable and Chapter 5A, as the same may be amended from time to time, hereby adopts the following Certificate of Formation for **MAY & STUCKEY, LLC** (the “Limited Liability Company”):

**ARTICLE ONE
NAME**

The name of the Limited Liability Company is **MAY & STUCKEY, LLC**.

**ARTICLE TWO
PERIOD OF DURATION**

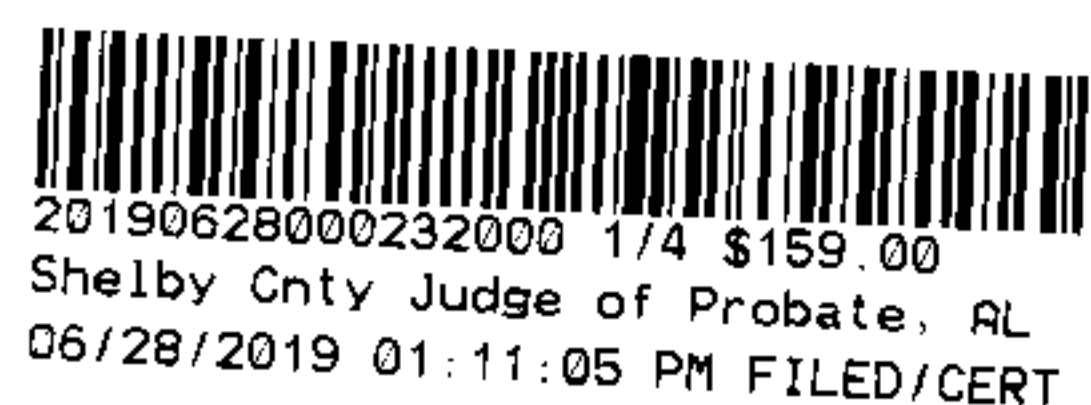
The Limited Liability Company shall continue in existence until dissolved in accordance with the provisions of the Limited Liability Company’s Operating Agreement, or, if there is no provision in an Operating Agreement of the Limited Liability Company governing dissolution of the Limited Liability Company, then in accordance with the provisions of the Alabama Limited Liability Company Law.

**ARTICLE THREE
PURPOSE**

The business of the company shall be, to the extent permitted by law, (1) to engage in the provision of professional legal services (2) to have and exercise all powers set forth in Code of Alabama (1975), Sections 10A-1-2.11, 2.12, and 2.13, as the same may be amended from time to time; and (3) to engage in any lawful business or other activity, related or incidental to any of the foregoing activities.

INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

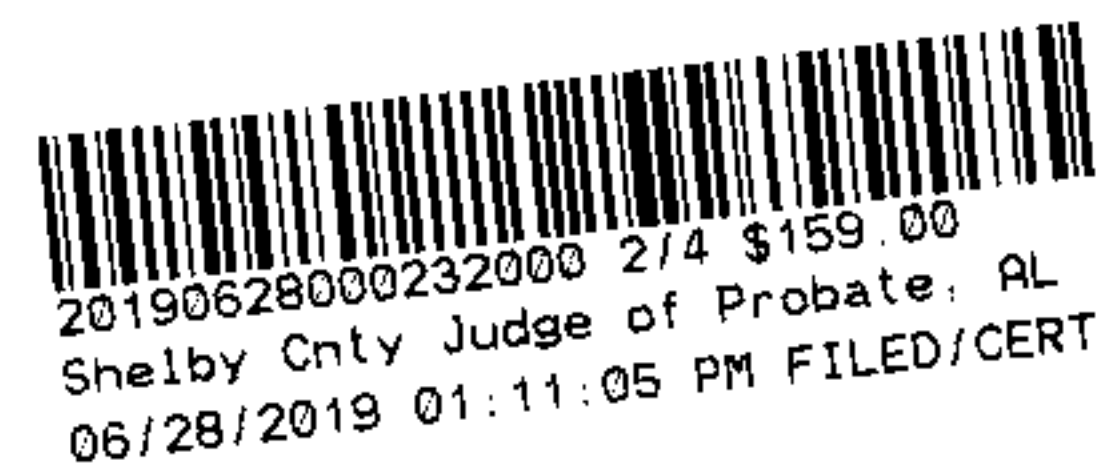
**ARTICLE SEVEN
ADDITIONAL MEMBERS**

Additional members may be admitted in accordance with the terms of the Limited Liability Company's Operating Agreement, if any. If the Limited Liability Company does not have an operating agreement that provides for the admission of additional members, additional members may be admitted with the written consent of all members at such times and upon such terms and conditions as may be mutually agreed upon by the members and the person desiring to become a member.

**ARTICLE EIGHT
CONTINUATION OF THE BUSINESS**

In the event there are no remaining members, and except as otherwise provided in the Limited Liability Company Operating Agreement, if any, the Limited Liability Company shall be dissolved and its affairs shall be wound up unless:

(a) the holders of all of the financial rights in the Limited Liability Company agree in writing within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Limited Liability Company and to appoint one or more new members; or



(b) The legal existence and business of the Limited Liability Company is continued and one or more new members are appointed in the manner stated in an operating agreement of the Limited Liability Company.

For the purpose of this Article, all of the financial rights owners means interests of one or more remaining financial rights owners which, when taken together, own one hundred percent (100%) of the capital interests and one hundred percent (100%) of the profits interests of the remaining financial rights owners.

ARTICLE NINE MANAGEMENT

The management of the Company is vested in its members. The name and address of the initial members of the Company are as follows: William Randall May, Esq., 300 Cahaba Park Circle, Suite 100, Birmingham, Alabama 35242; and, Jason A. Stuckey, Esq. 300 Cahaba Park Circle, Suite 100, Birmingham, Alabama 35242. Subject to any provisions in an operating agreement of the Company, or the provisions of the Alabama Limited Liability Company Act restricting or enlarging the management rights and duties of any person or group or class of persons, the members shall have the right and authority to manage the business or affairs of the Limited Liability Company and to make all decisions with respect thereto.


ARTICLE TEN AMENDMENT OF ARTICLES OF ORGANIZATION

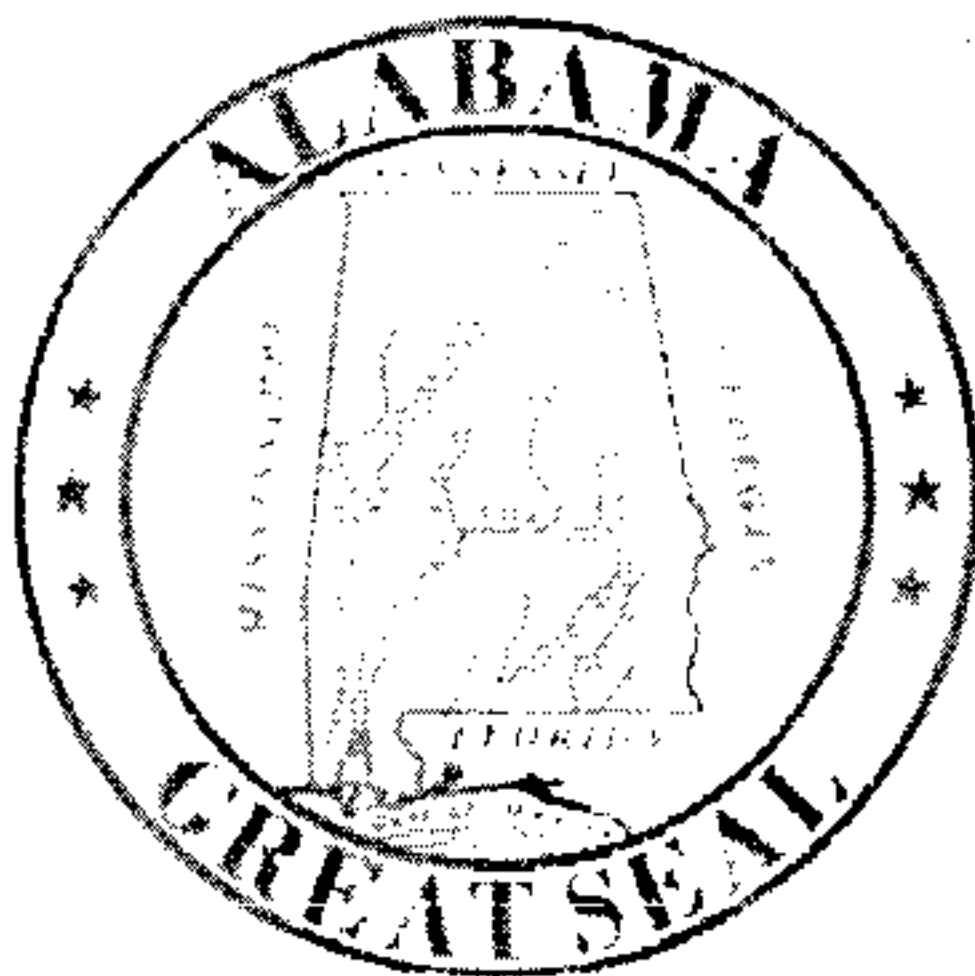
