KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Ninety Thousand Dollars and NO/100 (\$290,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Jeffrey D. Lovell and Molly C. Lovell, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Roya Daftarian and Tyler Neely** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in SHELBY County, Alabama to wit:

Lot 16, according to the Survey of Quail Run as recorded in Map Book 7, Page 22, in the Probate Office of Shelby County, Alabama.

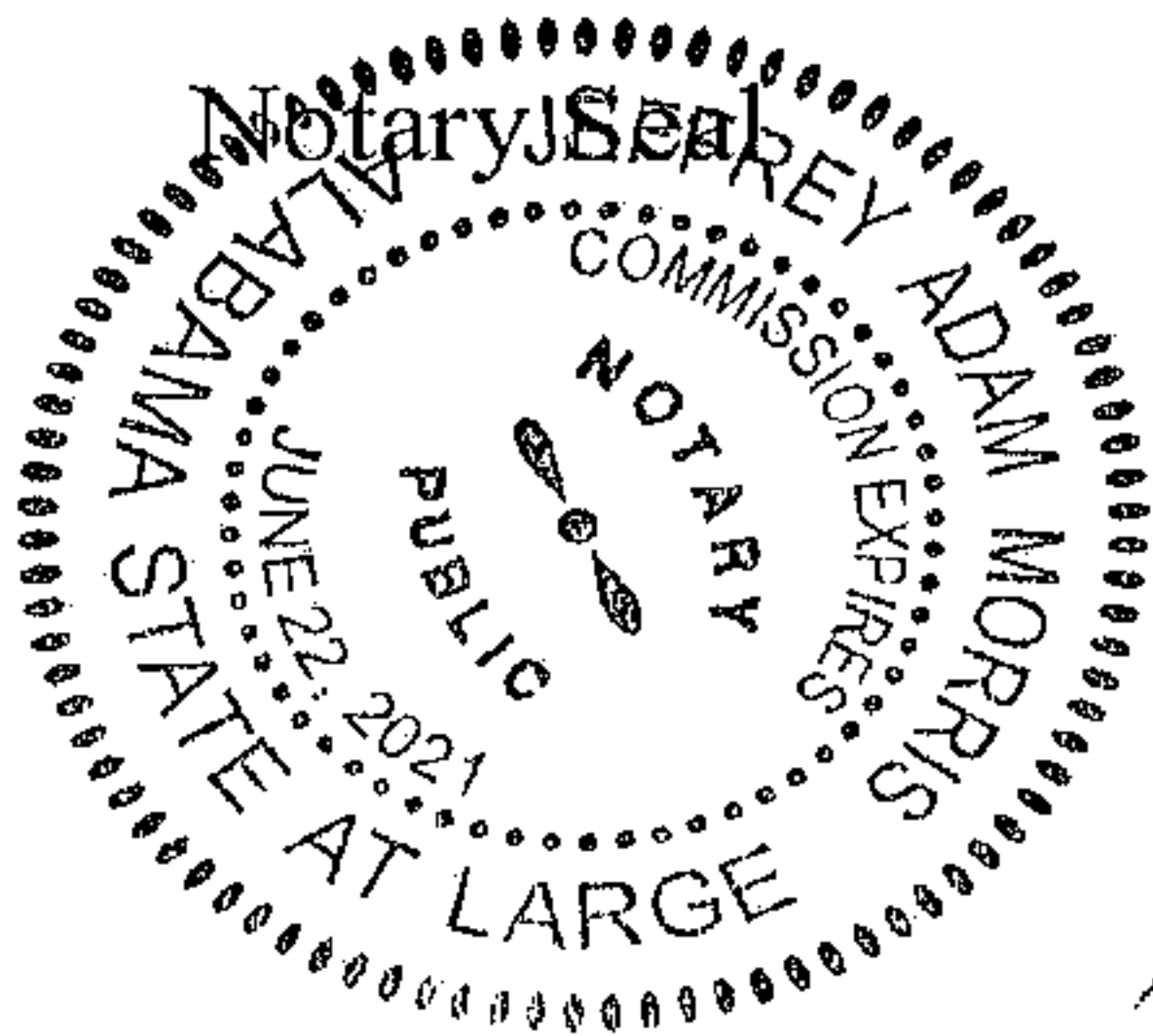

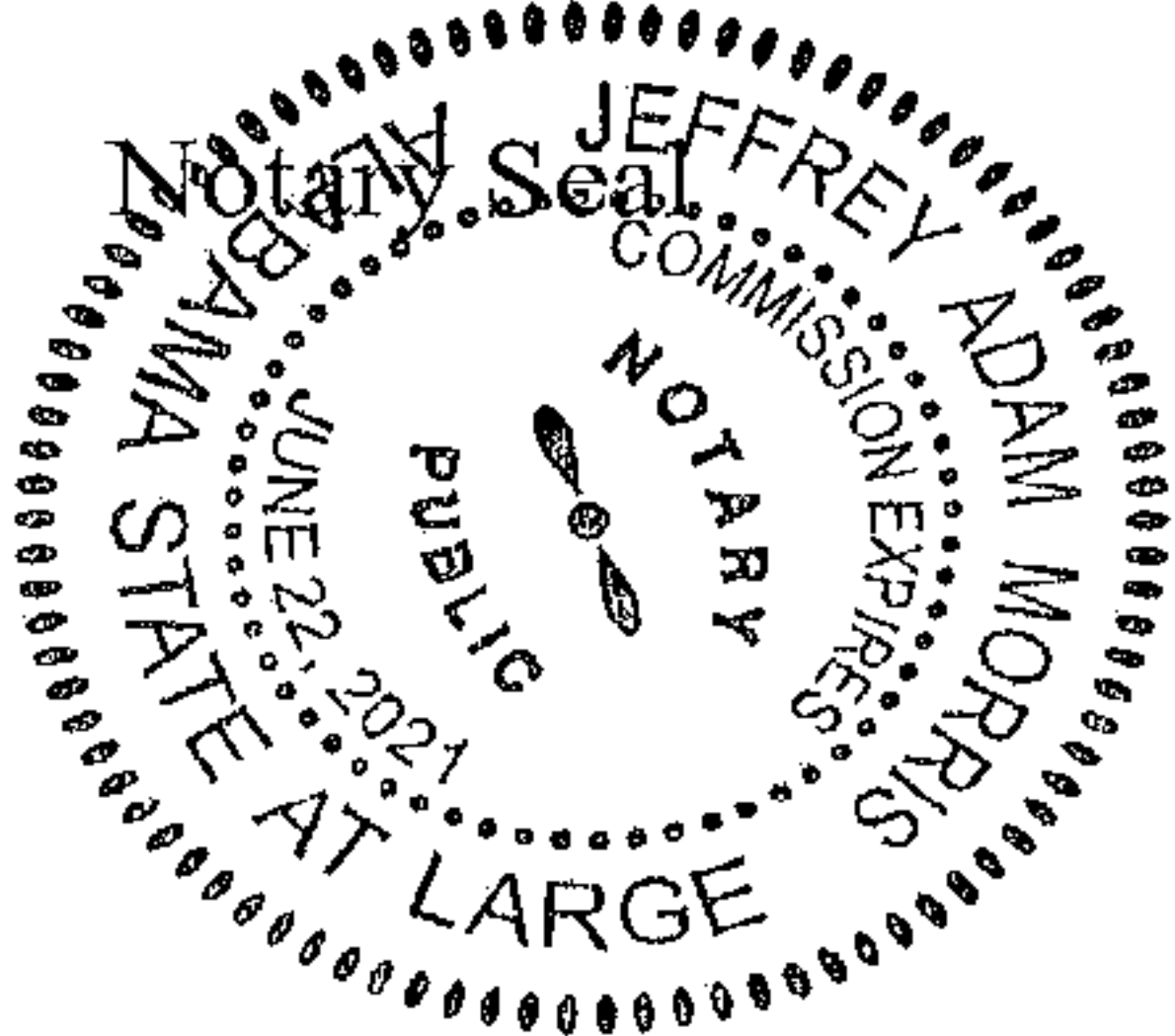

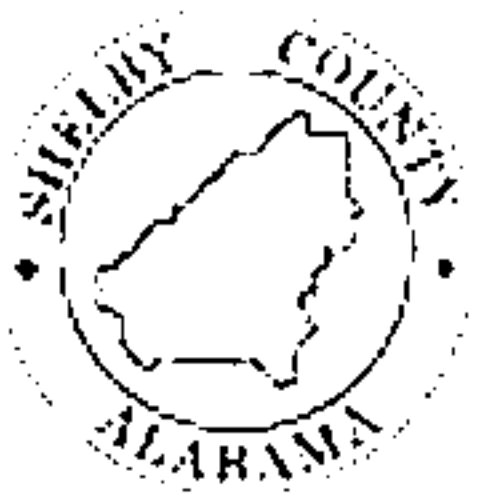
