
**CERTIFICATE OF JUDGMENT**

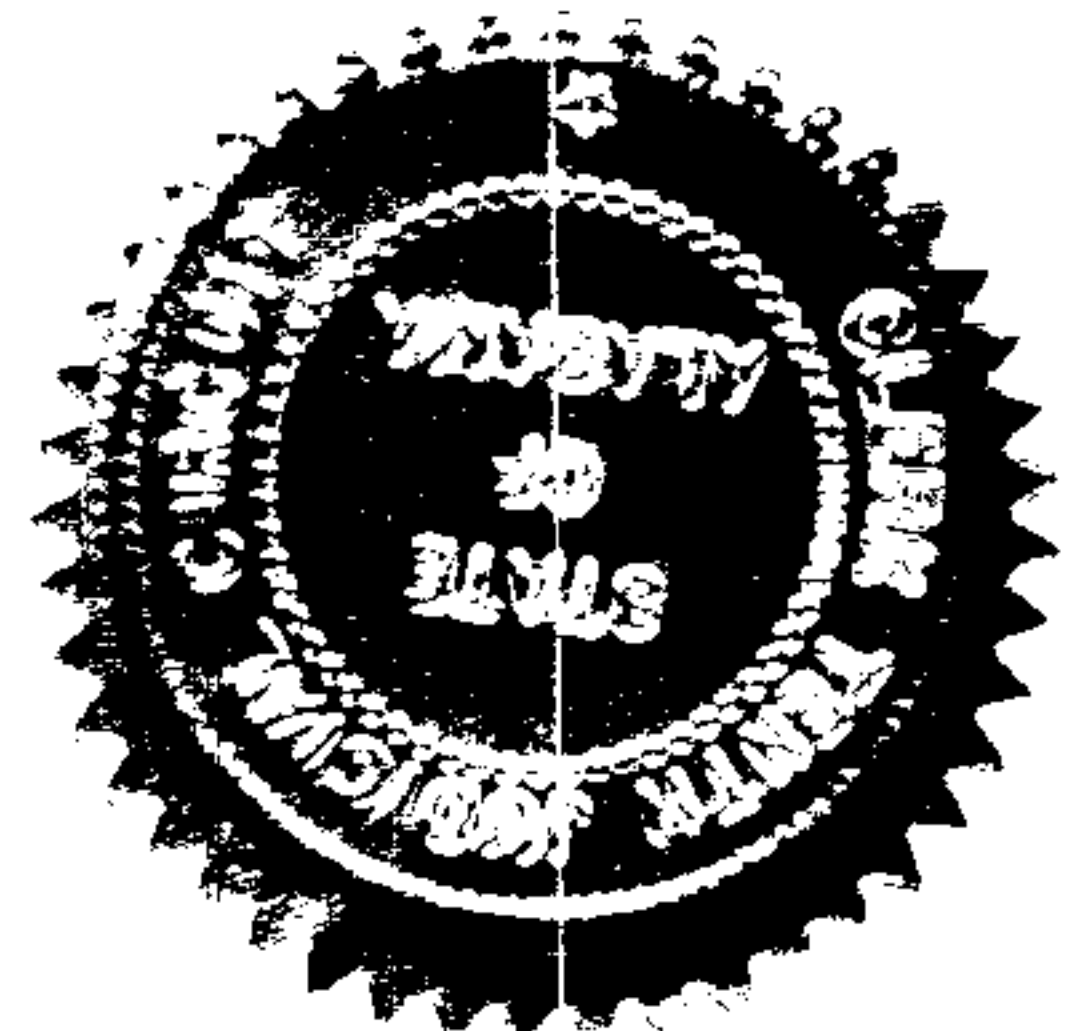
The Court **ORDERED, ADJUDGED** and **DECREED:**

**ORDER PURSUANT TO ALA. CODE SECTION 6-9-192 REVIVING JUDGMENT  
AGAINST RICHARD M. SCRUSHY**

THIS MATTER came before the Court on the Motion Pursuant to Ala. Code § 6-9-192 to Revive Judgment Against Richard M. Scrushy (the "Motion").

Based on the entire record in this case, the affidavits of John W. Haley and Michael E. Henderson in support of the Motion, the representations of counsel, and all other matters brought before the Court, and for the reasons stated in the Motion, the Court has determined that the relief requested in the Motion is due to be **GRANTED**.

Based on the foregoing findings of fact and conclusions of law, the Court hereby **ORDERS, ADJUDGES and DECREES** as follows:

1. The Motion is GRANTED.
2. The Court's judgment dated June 18, 2009 in favor of Derivative Plaintiffs, Wade C. Tucker and the Wendell J. Cook, Sr. Testamentary Trust, John P. Cook, Trustee and Encompass Health Corporation (f/k/a HealthSouth Corporation) (collectively,

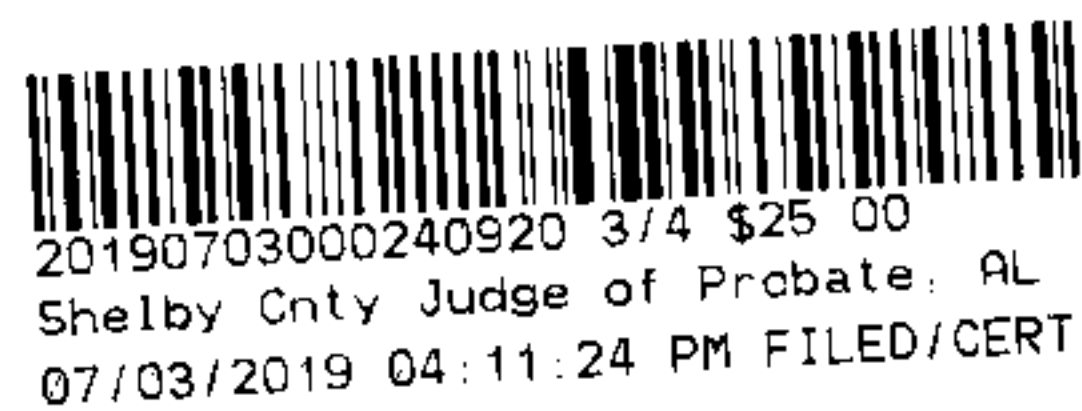

"Judgment Creditors") and against Richard M. Scrushy in the amount of two billion, eight hundred seventy six million, one hundred three thousand dollars (\$2,876,103,000.00) (the "Judgment") is hereby REVIVED.

3. Judgment Creditors may continue to execute on the Judgment, and otherwise pursue all rights and remedies to recover the Judgment, as allowed under applicable law, including without limitation the law of any foreign jurisdictions where the Judgment has been or may be domesticated.
4. Immediately upon entry of this Order, Judgment Creditors may record this Order and/or a renewed certificate of judgment (referencing the Judgment and this Order reviving the Judgment), in the probate records of Jefferson County, Alabama or elsewhere. The priority of Judgment Creditors' lien shall remain effective and have priority as of the date of recording the first certificate of judgment against Richard M. Scrushy in the County at issue.
5. The Judgment shall continue to accrue interest at the applicable legal rate from the original date of the Judgment.

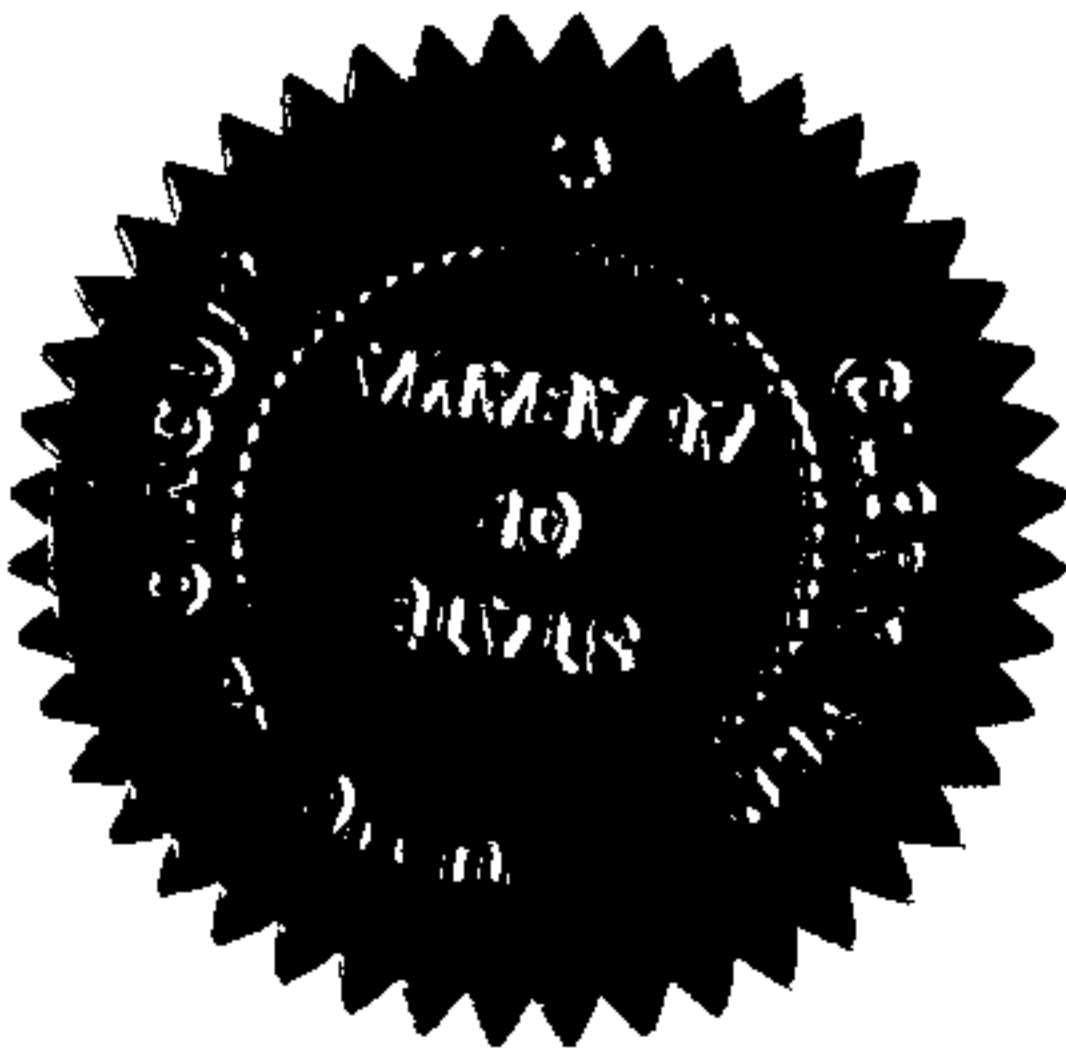
