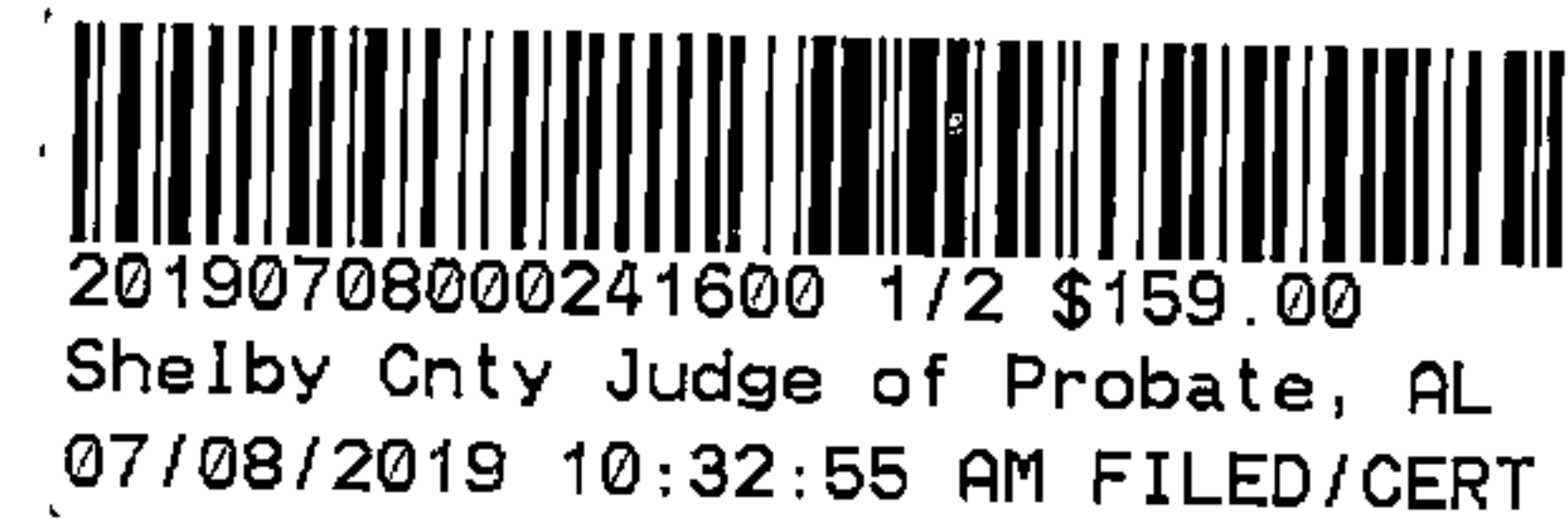

2.     **Initial Registered Office.** The street address and mailing address of the initial registered office of the Company is 1017 Inverness Cove Way, Birmingham AL 35242.


3.     **Initial Registered Agent.** The name of the Company's initial registered agent at the registered office is Will Post.
