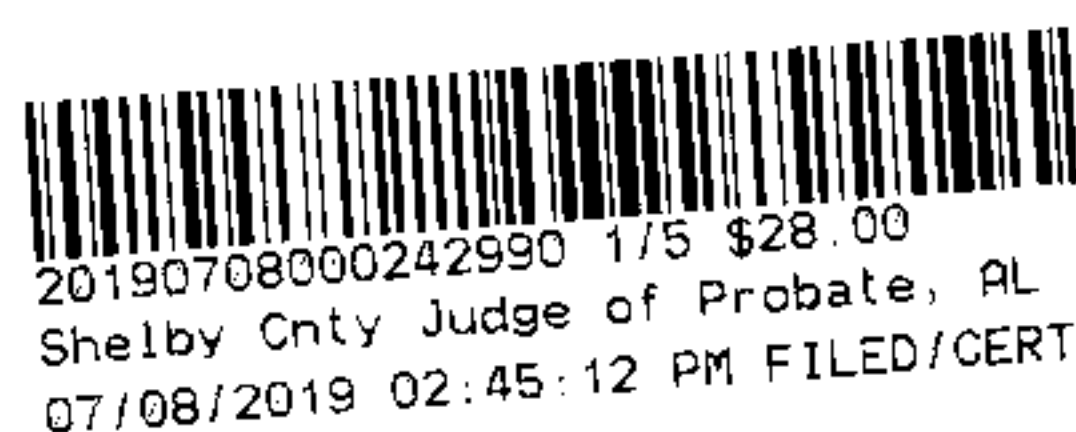
**RIGHT OF WAY DEED
FOR PERMANENT EASEMENT**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **TWO THOUSAND** dollar(s) cash in hand paid, the receipt of which is hereby acknowledged, as I (we), the undersigned grantor(s), **Stella H. Watkins**, a widow, have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Shelby County, a political subdivision of the State of Alabama, a permanent easement and right of way including all right, title and interest in and to all timber growing or at any time located within the right of way and easement limits, upon the land hereinafter described, together with the right to locate or relocate utilities, and to enter upon such described land and grade, level, fill, drain, pave, build, maintain, repair, and rebuild a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary, on, over and across such right of way easement. The easement and right of way hereby granted is more particularly located and described as follows:

A part of the NW ¼ of Section 36, Township 21 South, Range 3 West, identified as Tract No. 3 on Project No BRZ-5914() in Shelby County, Alabama and being more fully described as follows:

Parcel 1 of 1: Commencing at a capped iron pipe on the southern R/W line of CR-24, which is the NW property corner of Sherwood Stamps, as recorded in instrument #20100625000201780 in the probate office of Shelby County, Alabama, said point being the POINT OF COMMENCEMENT, thence Easterly and along the present southern R/W line of CR-24 a distance of 379.00 feet, more or less, to a point where the present southern R/W line of CR-24 intersects the centerline of Spring Creek, said point being the POINT OF BEGINNING, thence N 88°21'08" E and along said present southern R/W line a distance of 257.03 feet, more or less, to a concrete monument; thence following the curvature thereof an arc distance of 125.65 feet and along said present southern R/W line to a point on the acquired R/W line (said arc having a chord bearing of N 84°09'34" E, a counterclockwise direction, a chord distance of 125.53 feet, more or less, and a radius of 858.51 feet); thence S 75°00'33" W and along said acquired R/W line a distance of 153.84 feet to a point on the acquired R/W line; thence S 87°24'07" W and along said acquired R/W line a distance of 244.28 feet to a point on the centerline of Spring Creek, which is also the grantor's western property line; thence N 19°25'11" E and along said line a chord distance of 32.55 feet, more or less; to the point and place of BEGINNING, containing 0.19 acres, more or less.;

And as shown on the right of way map of record in Shelby County Highway Department, a copy of which is also deposited in the office of the Judge of Probate as an aid to persons and entities interested therein, and as shown on the Property Sketch attached hereto and made a part hereof.



TO HAVE AND TO HOLD, the said easement and right of way including all right, title, and interest in and to such timber aforementioned unto Shelby County, a political subdivision of the State of Alabama, and unto its successors and assigns forever.

And the said grantor(s) hereby covenant(s) with Shelby County, a political subdivision of the State of Alabama, that I (we) am (are) lawfully seized and possessed of the afore-described tract or parcel of land; that I (we) have a good and lawful right to sell and convey it; that it is free from all encumbrances; and that I (we) will warrant and forever defend the title and quiet possession thereto against the lawful claims of all persons whomsoever.

As a further consideration for the payment of the purchase price, above stated, I (we) hereby release Shelby County, a political subdivision of the State of Alabama, its employees and officials, from all claims for damage, from whatsoever cause, present or prospective, incidental or consequential, to the exercise of any of the rights herein granted.

The grantor hereby grants permission, with right of ingress to and egress from, grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right of way.



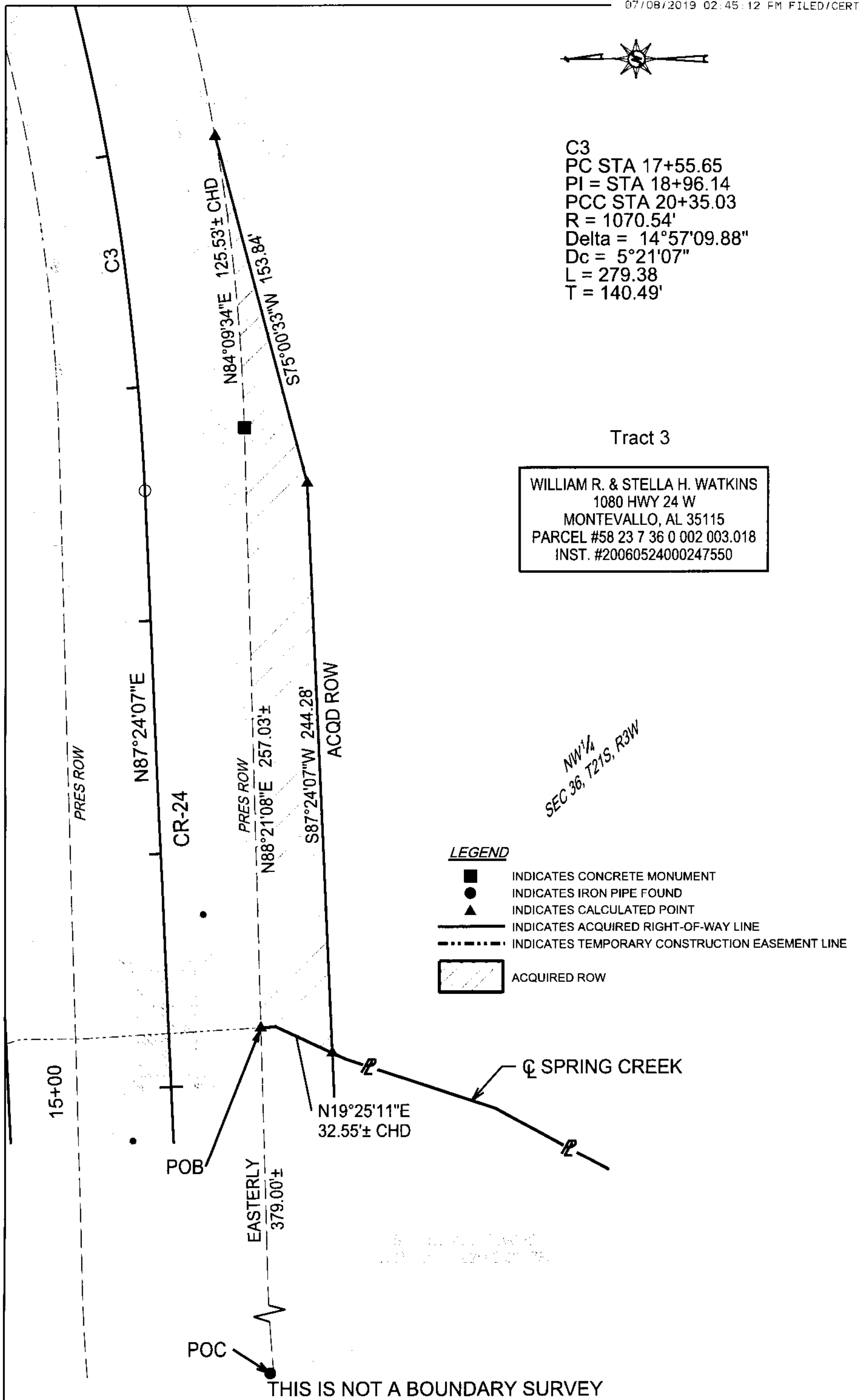
