
## RIGHT OF WAY DEED FOR PERMANENT EASEMENT

The easement and right of way hereby granted is more particularly located and described as follows:

A part of the NW ¼ of Section 36, Township 21 South, Range 3 West, identified as Tract No. 3 on Project No BRZ-5914( ) in Shelby County, Alabama and being more fully described as follows:


