\$380,800.00 of the purchase price recited above has been paid by a mortgage loan closed simultaneously herewith.

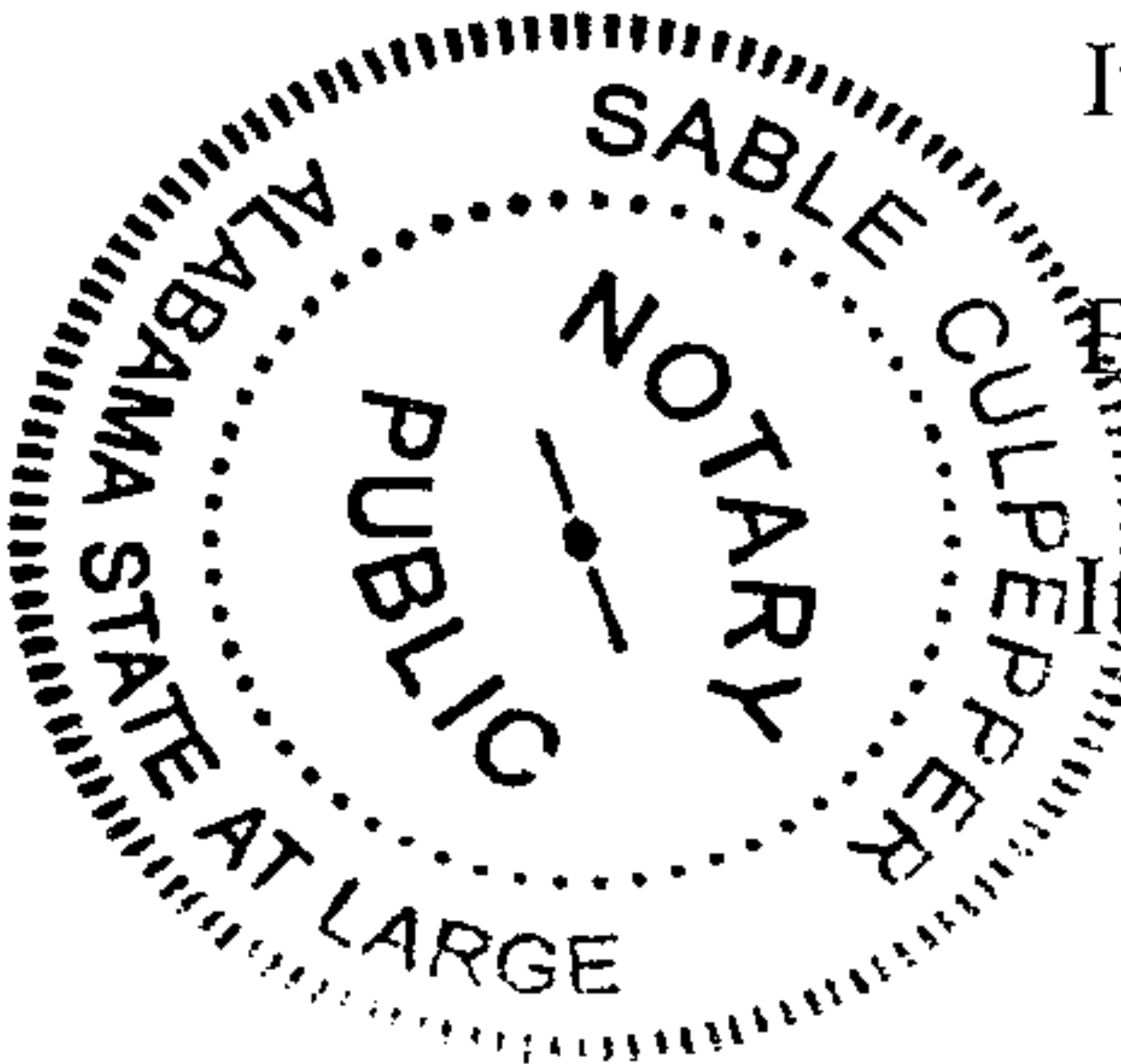
