## **WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

That in consideration of **Two Hundred Seventy-Five Thousand and 00/100 Dollars** (\$275,000.00) to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**Jeffrey L. Wolfe and his wife, Barbara B. Wolfe**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**Felix Tarrant Hoke, Jr. and Elizabeth Frommeyer Hoke**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

**Lot 14, according to the Survey of Villas Belvedere, as recorded in Map Book 29, pages 27 A & B,  
in the Probate Office of Shelby County, Alabama.**

\$220,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2019 ad valorem taxes not yet due and payable;






