2. To incorporate, file the original Articles of Organization and the Certificate of Name Reservation in the county where the Corporation's registered is located. The Secretary of State's filing fee is \$100. The Judge of Probate's filing fee is \$56.



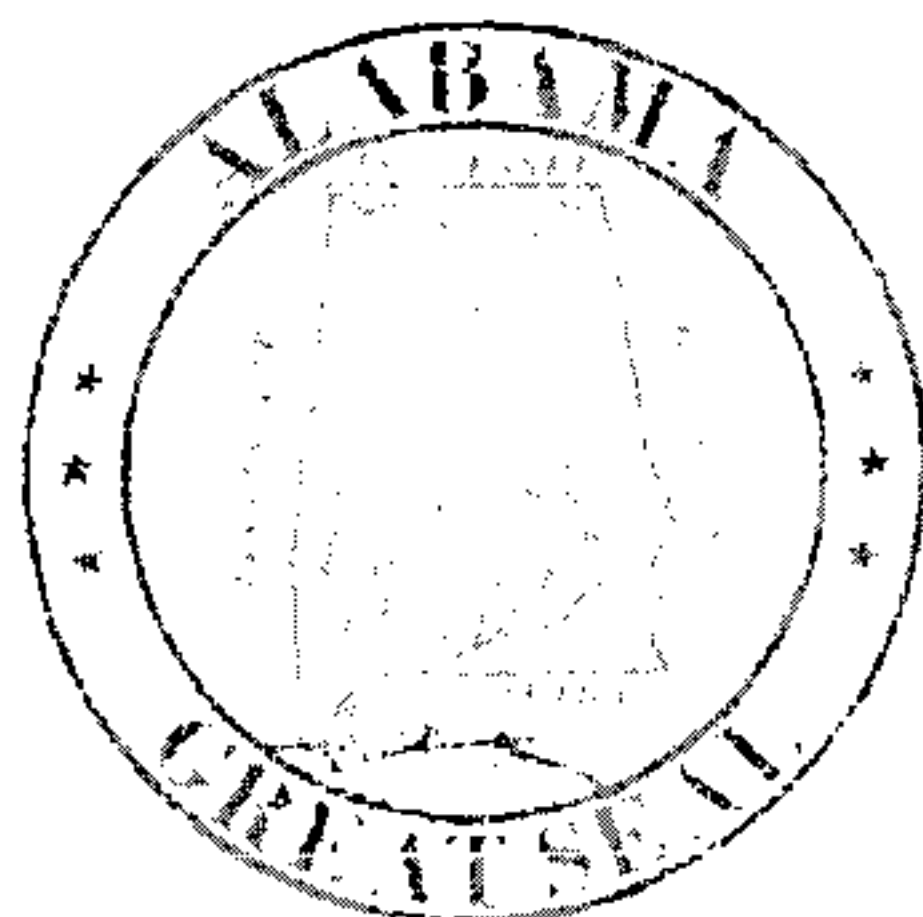
