- 3. To perform such acts, to participate in such proceedings and to exercise such other rights and privileges in respect to any property, as if he or she were the absolute owner thereof, and in connection therewith to enter into and execute any and all agreements binding my estate and any trust created hereunder;
- To compromise, settle or adjust any claim or demand by or against my estate, or any trust, to litigate any such claims, including, without limitation, any claims relating to estate or income taxes, or agree to rescind or modify any contract or agreements; and,
- All other powers and authority granted by law or necessary or appropriate for proper administration of my estate.

I direct that neither my original nor any successor Executor shall be required to furnish any bond or other security, or to file an inventory or appraisal of my estate in any Court although they shall make out and keep an inventory and shall exhibit the same to any party in interest at any reasonable time. I further direct that in the exercise of the above powers, the Executor, whether original or successor, shall be free from the control and supervision of the Probate Court or any other Court. No successor, Executor or Executors, shall be liable for any act of any predecessor Executor or Executors. Any Executor, whether original or successor, shall have the right to resign at any time and for any reason, and without leave of Court, by filing an instrument of resignation with the Clerk of the Court in which this Will is probated.

#### ARTICLE THREE

I direct that all debts shall be legally owed by me, my funeral expenses and expenses of administration of my estate be paid by my Executor as soon as practicable.

### ARTICLE FIVE


