**On this July 24, 2019**, That for and in consideration of **THREE HUNDRED TEN THOUSAND AND NO/100 (\$310,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **PATRICIA CANTAVESPRE, TRUSTEE OF THE PATRICIA CANTAVESPRE REVOCABLE TRUST DATED SEPTEMBER 18, 2008**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **KEVIN W.
