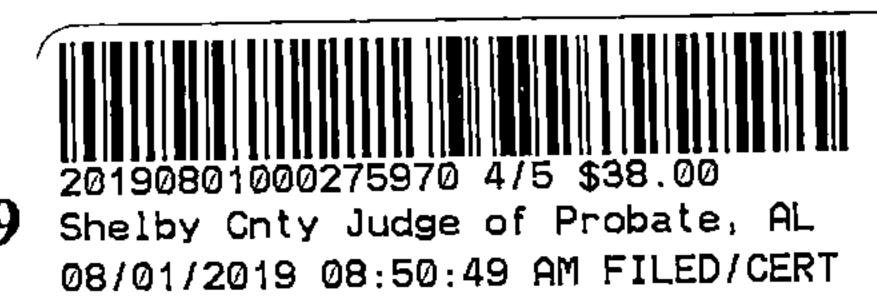

#### Schedule A

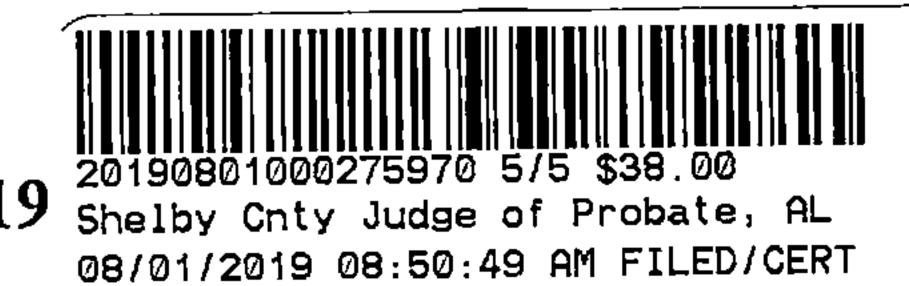
