Know All Men by These Presents: That in consideration of **One Hundred Sixty-Eight Thousand and 00/100 Dollars (\$168,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor) grant, bargain, sell and convey unto **VYLSE D. ALDERSON and ALEXIS D. ALDERSON** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 16A, according to the Survey of Amended Map of Ammersee Lakes Second Sector, as recorded in Map Book 36, Page 99, in the Probate Office of Shelby County, Alabama.

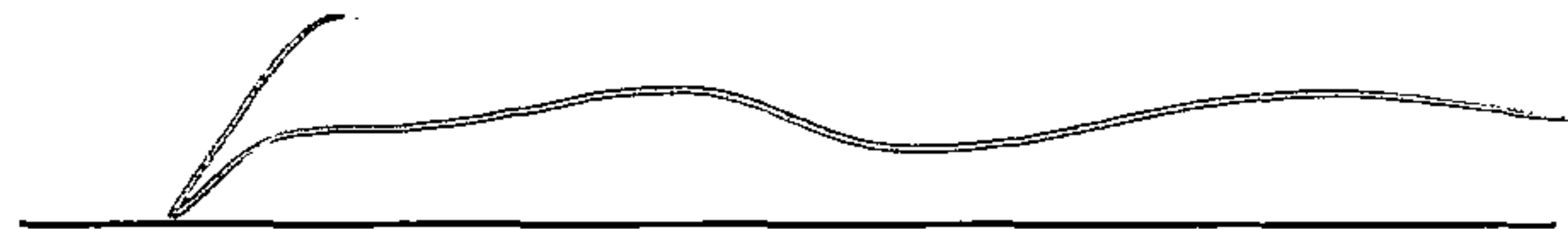

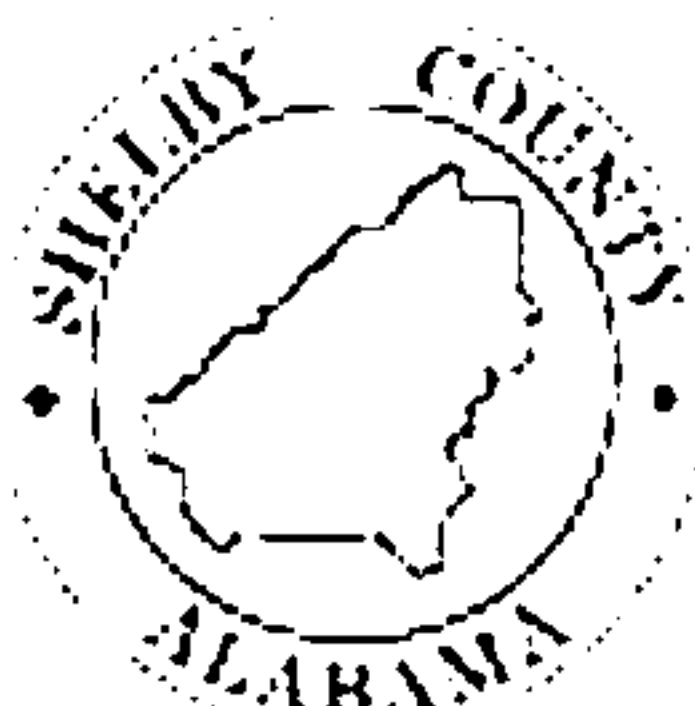
