Know All Men by These Presents: That in consideration of **Three Hundred Eighty Thousand and 00/100 Dollars (\$380,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **CHARLES W. BOUYER, SR. and PATRICIA W. BOUYER, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **MICHAEL D. FURR and KATHRYN M. FURR** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:



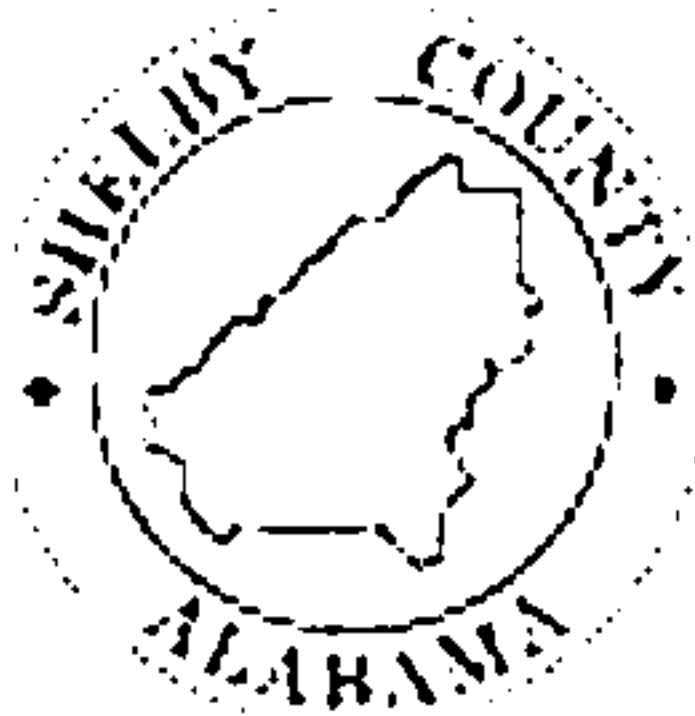
