ARTICLE I

Name

The effective date of the Dissolution of BTT, LLC shall be August 2, 2019.


ARTICLE V



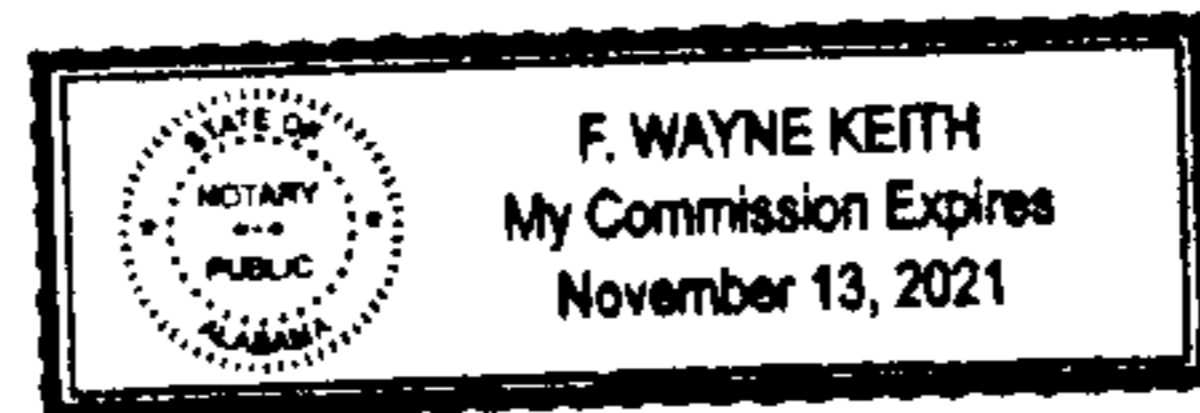
