Know All Men by These Presents: That in consideration of **Four Hundred One Thousand Eight Hundred Eighty and no/100 Dollars (\$401,880.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **JAMES A. WRIGHT and ASHLEY G. WRIGHT** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

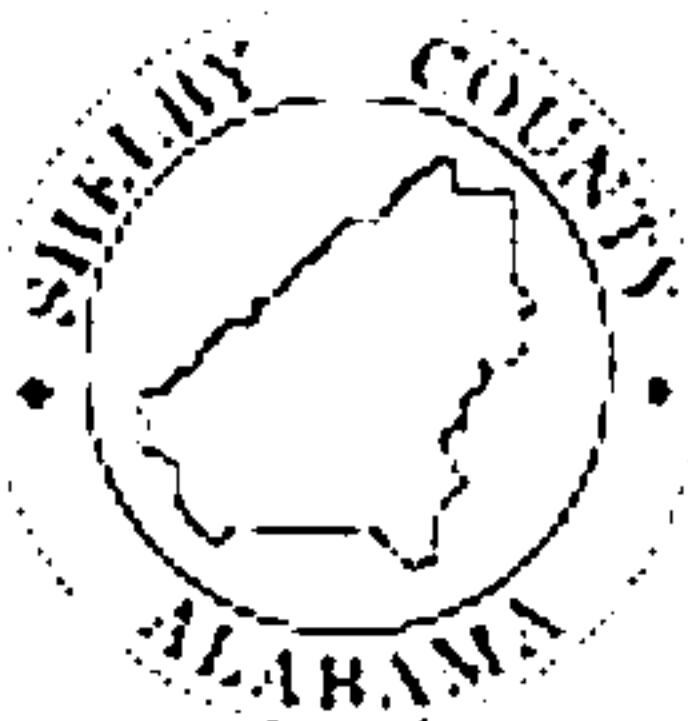
