Subject To:


- (1) Advalorem taxes for the 2019 and subsequent years due and payable as of October 1, 2019;



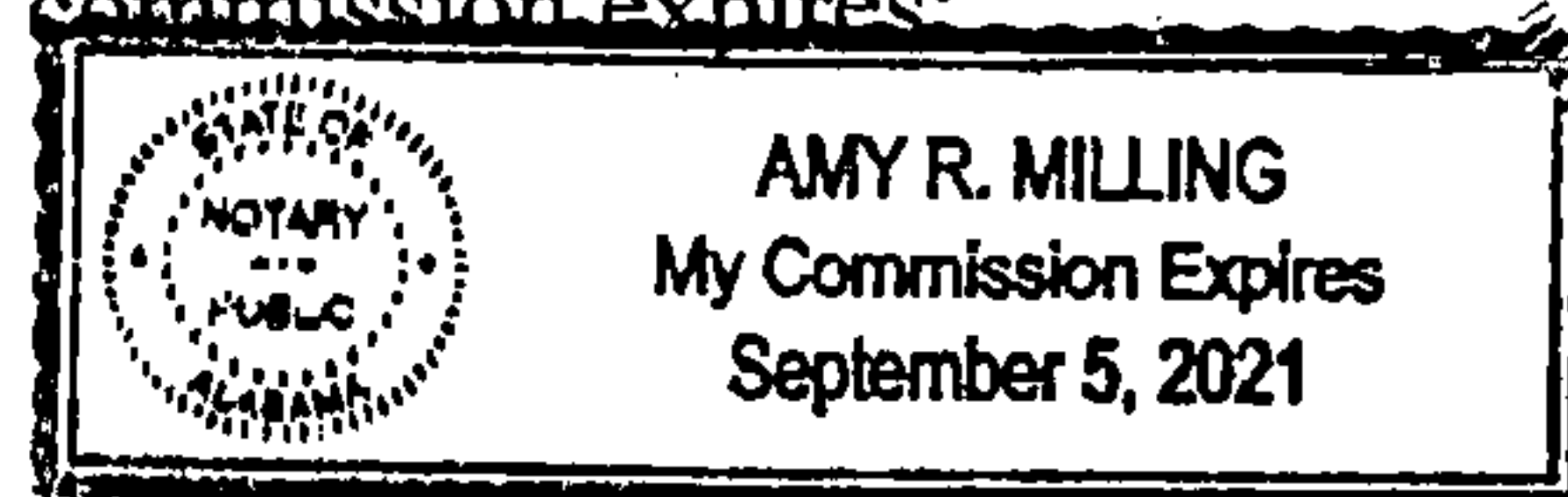
