Know All Men by These Presents: That in consideration of **One Thousand Seven Hundred Seventy-Seven and 00/100 Dollars (\$177,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **ANNIECE A. MALLARD, a married woman** (herein referred to as Grantor), grant, bargain, sell and convey unto **JOSEPH M. FRIDAY and ARIANA FRIDAY** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot # 10 of Block 2 of the 1st Addition to Alabaster Highland Sub-division, according to Map Book 4, Page 85, in the Office of the Probate Judge, Shelby County, Alabama.
