**RELEASE OF MORTGAGE, ASSIGNMENT OF LEASES AND RENTS, SECURITY  
AGREEMENT AND FIXTURE FILING**

GOLDMAN SACHS SPECIALTY LENDING GROUP, L.P., a Delaware limited partnership (the “**Grantee**”), is the owner and holder of that certain Mortgage, Assignment of Leases and Rents, Security Agreement and Fixture Filing made by Ruby Tuesday, Inc., a Georgia corporation (the “**Grantor**”) in favor of Grantee, dated as of December 21, 2017, recorded March 9, 2018 as Document No. 20180309000076470, in the Shelby County, Alabama Records (the “**Security Agreement**”).

Such indebtedness is secured by other mortgages, deeds of trust and deeds to secure debt on properties other than the property secured by the Security Agreement. This release of the Security Agreement is not intended to and does not satisfy, cancel, discharge or release any other mortgage, deed of trust or deed to secure debt securing all or any portion of such indebtedness.

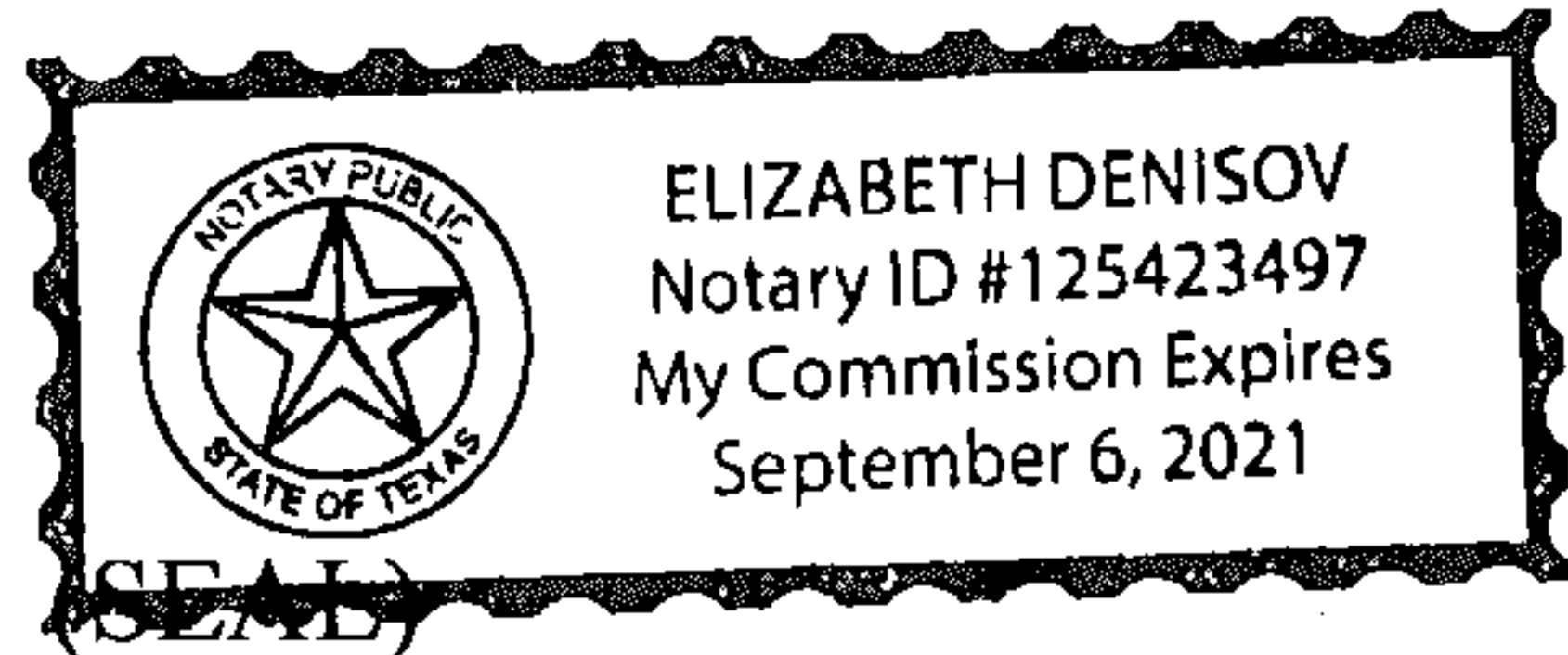
