That in consideration of the sum of **One Hundred Eighty Eight Thousand Dollars and No Cents (\$188,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Luedella M Klimt**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Celia D Thacker and Betty D Martin**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama; to wit;

Lot 1, Block B, according to the Map of River View Subdivision as recorded in Map Book 4, Page 63, in the Probate Office of Shelby County, Alabama.


Property constitutes no part of the homestead of the Grantor herein or her spouse.



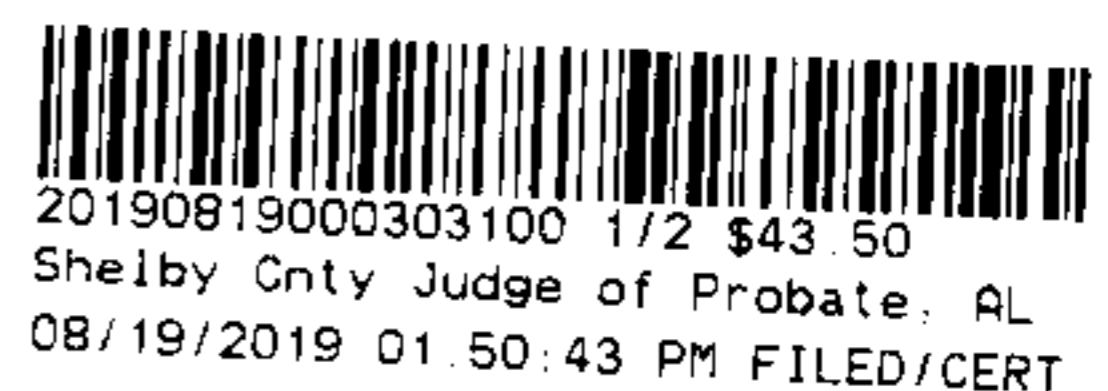
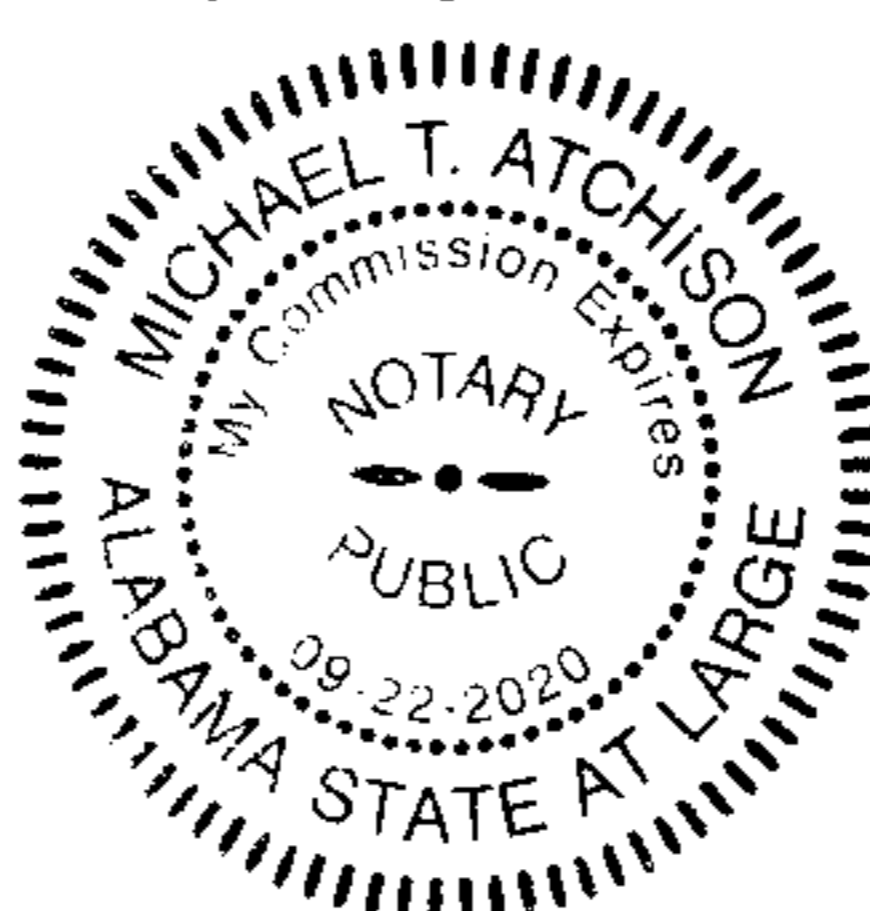
